STIPULATION AND AGREEMENT OF SETTLEMENT

This Stipulation and Agreement of Settlement, dated as of October 8, 2021 (the "Stipulation") is entered into between (a) Lead Plaintiff Jet Capital Master Fund, L.P. ("Jet Capital"), on behalf of itself and the HRG Subclass (defined below); and (b) Defendants Spectrum Brands Holdings, Inc. ("Spectrum" or the "Company"), Spectrum Brands Legacy, Inc. ("Old Spectrum"), HRG Group, Inc. ("HRG"), Andreas R. Rouvé, David M. Maura, and Douglas L. Martin (collectively, "Defendants"), and embodies the terms and conditions of the settlement of the above-captioned action (the "Action"). Subject to the approval of the Court and the terms and conditions expressly provided herein, this Stipulation is intended to fully, finally, and forever compromise, settle, release, resolve, and dismiss with prejudice all claims asserted by the HRG Subclass in the Action and all Released Plaintiffs' Claims (defined below) against Defendants.

WHEREAS:

A. Beginning on March 7, 2019, certain related class actions (*Earl S. Wagner v. Spectrum Brands Legacy, Inc., et al.*, No. 19-cv-178-jdp, and *West Palm Beach Firefighters' Pension Fund v. Spectrum Brands Legacy, Inc., et al.*, No. 19-cv-347-jdp) were filed in the United

States District Court for the Western District of Wisconsin (the "Court") alleging violations of the federal securities laws.

- B. By Opinion and Order dated June 12, 2019, the Court: (i) consolidated the related actions in the action captioned *In re Spectrum Brands Securities Litigation*, No. 19-cv-347-jdp (W.D. Wis.) (the "*Spectrum* Action"); (ii) appointed the Public School Teachers' Pension and Retirement Fund of Chicago and the Cambridge Retirement System to serve as lead plaintiffs (the "Spectrum Subclass Lead Plaintiffs"); and (iii) approved the Spectrum Subclass Lead Plaintiffs' choice of Bernstein Litowitz Berger & Grossmann LLP as lead counsel and Rathje Woodward LLC as liaison counsel.
- C. On July 12, 2019, the Spectrum Subclass Lead Plaintiffs filed the Amended Class Action Complaint for Violations of the Federal Securities Laws (the "Amended Complaint" or "Complaint") in the *Spectrum* Action asserting claims against Defendants Spectrum, Old Spectrum, and the Individual Defendants under Section10(b) of the Securities Exchange Act of 1934 (the "Exchange Act") and Rule 10b-5 promulgated thereunder, and against the Individual Defendants and Defendant HRG under Section 20(a) of the Exchange Act. Among other things, the Amended Complaint alleged that Defendants made materially false and misleading statements about the Company's operations and financial results during the *Spectrum* Action Class Period. The Amended Complaint further alleged that the prices of Spectrum's, Old Spectrum's, and HRG's common stock were artificially inflated during the *Spectrum* Action Class Period as a result of Defendants' allegedly false and misleading statements, and declined when the truth was revealed.
- D. On August 26, 2019, Defendants filed their motion to dismiss the Amended Complaint (the "Motion to Dismiss"). On October 10, 2019, the Spectrum Subclass Lead Plaintiffs

filed their memorandum of law in opposition to Defendants' Motion to Dismiss and, on November 6, 2019, Defendants filed their reply papers in further support of the Motion to Dismiss.

- E. On January 7, 2020, the Spectrum Subclass Lead Plaintiffs and Defendants filed a letter notifying the Court that they had agreed to a mediation of the *Spectrum* Action before a private mediator and jointly requested that the Court defer decision on the fully briefed motion to dismiss pending the outcome of the mediation. That same day, the Court entered an order denying without prejudice the Motionto Dismiss.
- F. On June 3, 2020, the Spectrum Subclass Lead Plaintiffs and Defendants conducted a full-day mediation under the auspices of Jed Melnick, Esq. of JAMS (the "Mediator"). The session ended without any agreement being reached.
- G. Following the mediation session, the Spectrum Subclass Lead Plaintiffs and Defendants engaged in additional settlement negotiations under the supervision and guidance of the Mediator. On August 10, 2020, the Spectrum Subclass Lead Plaintiffs and Defendants entered into a Stipulation and Agreement of Settlement providing for the settlement of the *Spectrum* Action for \$39 million in cash (the "Prior Settlement"). The Prior Settlement was on behalf of a settlement class consisting of persons and entities who purchased Spectrum, Old Spectrum, or HRG common stock during the period from January 26, 2017 to November 19, 2018, inclusive (the "*Spectrum* Action Class Period"), and were damaged thereby.
- H. On January 8, 2021, Jet Capital (along with Jet Capital SRM Master Fund, L.P. and Walleye Investments Fund, also represented by Lead Counsel) objected to the Prior Settlement and sought to intervene in the *Spectrum* Action, arguing that (i) the Spectrum Subclass Lead Plaintiffs were not adequate representatives for purchasers of HRG common stock, under the PSLRA and otherwise; and (ii) the plan of allocation in the Prior Settlement was unreasonable as

to purchasers of HRG common stock.

- I. On February 6, 2021, the Court entered an Order denying without prejudice the Spectrum Subclass Lead Plaintiffs' motion for final approval of the Prior Settlement and the intervention motion.
- J. Pursuant to the Court's February 6, 2021 Order, on February 19, 2021, the Spectrum Subclass Lead Plaintiffs submitted a proposed plan to the Court to divide the putative class into separate subclasses of Spectrum investors and HRG investors, and to provide a Private Securities LitigationReform Act ("PSLRA") notice for an additional lead plaintiff to represent the purchasers of HRG common stock during the Class Period (the "HRG Subclass").
- K. Upon approval by the Court, on April 2, 2021, the Spectrum Subclass Lead Plaintiffs issued the PSLRA notice to purchasers of HRG common stock during the asserted Class Period via *PRNewswire*.
- L. On May 26, 2021, Jet Capital moved to be appointed lead plaintiff for the HRG Subclass.
- M. On June 10, 2021, the Court granted Jet Capital's unopposed motion to serve as lead plaintiff for the HRG Subclass.
- N. The Spectrum Subclass Lead Plaintiffs, Defendants, and Jet Capital engaged in mediation before the Mediator in an effort to reach a settlement on behalf of both the Spectrum Subclass and the HRG Subclass, which included a formal mediation session on July 22, 2021.
- O. The Spectrum Subclass Lead Plaintiffs, Defendants, and Jet Capital were unsuccessful in negotiating a mutually acceptable allocation of the \$39 million in settlement consideration that had previously been agreed for both sub-classes.
 - P. On August 27, 2021, the Court ordered the claims of the HRG Subclass severed

from the *Spectrum* Action, and pursuant to the Court's August 27, 2021 Order, this Action was created, captioned *Jet Capital Master Fund, L.P. v. HRG Group, Inc.*, No. 21-cv-552-jdp.

- Q. Jet Capital and Defendants now seek to resolve the claims of the HRG Subclass. Jet Capital and Defendants reached an agreement in principle to settle the Action with respect to the HRG Subclass, which was memorialized in a term sheet executed on September 20, 2021 (the "Term Sheet"). The Term Sheet set forth, among other things, the Parties' agreement to settle and release all claims of the HRG Subclass against Defendants in the Action in return for a cash payment of \$7,250,000 for the benefit of the HRG Subclass, subject to certain terms and conditions and the execution of a customary "long form" stipulation and agreement of settlement and related papers.
- R. This Stipulation (together with the exhibits hereto) reflects the final and binding agreement between the Parties and supersedes the Term Sheet and the Prior Settlement.
- S. Jet Capital has concluded that the terms and conditions of this Stipulation are fair, reasonable, and adequate to Jet Capitaland the other members of the HRG Subclass, and in their best interests. Based on Jet Capital's direct oversight of the prosecution of this matter and with the advice of its counsel, Jet Capital has agreed to settle and release the Released Plaintiffs' Claims pursuant to the terms and provisions of this Stipulation, after considering, among other things:

 (a) the substantial financial benefit that Jet Capital and the other members of the HRG Subclass will receive under the proposed Settlement; and (b) the significant risks and costs of continued litigation and trial.
- T. This Stipulation constitutes a compromise of all matters that are in dispute between the Parties. Defendants are entering into this Stipulation solely to eliminate the uncertainty, burden, and expense of further protracted litigation. Each of the Defendants denies any wrongdoing, and

this Stipulation shall in no event be construed or deemed to be evidence of or anadmission or concession on the part of any of the Defendants with respect to any claim or allegation any fault or liability or wrongdoing or damage whatsoever, or any infirmity in the defenses that Defendants have, or could have, asserted. Defendants expressly deny that the Spectrum Subclass Lead Plaintiffs or Jet Capital has asserted any valid claims as to any of them, and expressly deny any and all allegations of fault, liability, wrongdoing, or damages whatsoever. Similarly, this Stipulation shall in no event be construed or deemed to be evidence of or an admission or concession on the part of Jet Capital of any infirmity in any of the claims asserted in the Action, or an admission or concession that anyof the Defendants' defenses to liability had any merit.

NOW THEREFORE, it is hereby STIPULATED AND AGREED, by and among Lead Plaintiff Jet Capital (individually and on behalf of all other members of the HRG Subclass) and Defendants, by and through their respective undersigned attorneys and subject to the approval of the Court pursuant to Rule 23(e) of the Federal Rules of Civil Procedure, that, in consideration of the benefits flowing to the Parties from the Settlement, all Released Plaintiffs' claims as against the Defendants' Releasees and all Released Defendants' Claims as against the Plaintiffs' Releaseesshall be settled and released, upon and subject to the terms and conditions set forth below.

DEFINITIONS

- 1. As used in this Stipulation and any exhibits attached hereto and made a part hereof, the following capitalized terms shall have the following meanings:
 - (a) "Action" means the securities class action in the matter styled *Jet Capital Master Fund, L.P. v. HRG Group, Inc.*, No. 21-cv-552-jdp.
 - (b) "Authorized Claimant" means an HRG Subclass Member who submits a Claim to the Claims Administrator that is approved by the Court for payment from the

Net Settlement Fund.

- (c) "Claim" means a paper claim submitted on a Proof of Claim Form or an electronic claim that is submitted to the Claims Administrator.
- (d) "Claim Form" or "Proof of Claim Form" means the form, substantially in the form attached hereto as Exhibit 2 to Exhibit A, that a Claimant must complete and submit should that Claimant seek to share in a distribution of the Net Settlement Fund. Claimants who previously submitted a claim form in connection with the Prior Settlement will not be required to submit a new Claim Form. The information those Claimants previously submitted will be used to calculate their claim for this Settlement.
- (e) "Claimant" means a person or entity who or which submits a Claim to the Claims Administrator seeking to be eligible to share in the proceeds of the Net Settlement Fund.
- (f) "Claims Administrator" means the firm retained by Lead Counsel, subject to approval of the Court, to provide all notices approved by the Court to potential HRG Subclass Members and to administer the Settlement.
- (g) "Class Distribution Order" means an order entered by the Court authorizing and directing that the Net Settlement Fund be distributed, in whole or in part, to Authorized Claimants.
- (h) "Complaint" means the Amended Class Action Complaint for Violations of the Federal Securities Laws filed by the Spectrum Subclass Lead Plaintiffs in the *Spectrum* Action on July 12, 2019.
 - (i) "Court" means the United States District Court for the Western District

of Wisconsin.

- (j) "Defendants" means Spectrum, Old Spectrum, HRG, and the Individual Defendants.
- (k) "Defendants' Counsel" means the law firms of Paul, Weiss, Rifkind, Wharton & Garrison LLP and Foley & Lardner LLP.
- (l) "Defendants' Releasees" means (i) Defendants; (ii) the present and former parents, subsidiaries, divisions, and affiliates of Spectrum, Old Spectrum, and HRG; (iii) the present and former employees, Officers, and directors of each of the foregoing in (i)-(ii); (iv) the present and former attorneys, insurers, and agents of each of the foregoing in (i)-(iii); and (v) the predecessors, heirs, successors, and assigns of each of the foregoing in (i)-(iv).
- (m) "Effective Date" with respect to the Settlement means the first date by which all of the events and conditions specified in ¶ 31 of this Stipulation have been met and have occurred or have been waived.
- (n) "Escrow Account" means an account maintained at Peapack-Gladstone
 Bank wherein the Settlement Amount shall be deposited and held in escrow under the
 control of Lead Counsel.
 - (o) "Escrow Agent" means Peapack-Gladstone Bank.
- (p) "Escrow Agreement" means the agreement between Lead Counsel and the Escrow Agent setting forth the terms under which the Escrow Agent shall maintain the Escrow Account.
 - (q) "Excluded Defendants' Claims" means (i) any claims relating to the

enforcement of the Settlement, and (ii) any claims against any person or entity who or which previously submitted a request for exclusion from the settlement class in connection with the Prior Settlement or any person or entity that submits a request for exclusion from the HRG Subclass that is accepted by the Court.

- (r) "Excluded Plaintiffs' Claims" means (i) any claims relating to the enforcement of the Settlement; (ii) any claims arising out of purchases of Old Spectrum common stock from January 26, 2017 to July 13, 2018; (iii) any claims arising out of purchases of Spectrum common stock from July 13, 2018 to November 19, 2018; (iv) any claims asserted in *Plymouth Cnty. Ret. Ass'n v. Spectrum Brands Holdings, Inc., et al.*, 2019CV000982 (Wis. Cir. Ct. Dane Cnty.); (v) any claims asserted in any derivative action or ERISA action; and (vi) any claims of any person or entity who or which previously submitted a request for exclusion from the settlement class in connection with the Prior Settlement or any person or entity that submits a request for exclusion from the HRG Subclass that is accepted by the Court.
- (i) if no appeal is filed, the expiration date of the time provided for filing or noticing any appeal under the Federal Rules of Appellate Procedure, i.e., thirty (30) days after entry of the judgment or order; or (ii) if there is an appeal from the judgment or order, (a) the date of final dismissal of all such appeals, or the final dismissal of any proceeding on certiorari or otherwise, or (b) the date the judgment or order is finally affirmed on an appeal, the expiration of the time to file a petition for a writ of certiorari or other form of review, or the denial of a writ of certiorari or other form of review, and, if certiorari or other form of review is granted, the date of final affirmance following review pursuant to that grant.

However, any appeal or proceeding seeking subsequent judicial review pertaining solely to an order issued with respect to (i) attorneys' fees, costs or expenses, or (ii) the plan of allocation of Settlement proceeds (as submitted or subsequently modified), shall not in any way delay or preclude a judgment from becoming Final.

- (t) "HRG" means HRG Group, Inc.
- (u) "Immediate Family" means children, stepchildren, parents, stepparents, spouses, siblings, mothers-in-law, fathers-in-law, sons-in-law, daughters-in-law, brothers-in-law, and sisters-in-law. As used in this paragraph, "spouse" shall mean a husband, a wife, or a partner in a state-recognized domestic relationship or civil union.
- (v) "Individual Defendants" means Andreas R. Rouvé, David M. Maura, and Douglas L. Martin.
- (w) "Judgment" means the final judgment, substantially in the form attached hereto as Exhibit B, to be entered by the Court approving the Settlement.
 - (x) "Lead Counsel" means the law firm of Rolnick Kramer Sadighi LLP.
 - (y) "Lead Plaintiff" means Jet Capital Master Fund, L.P.
- (z) "Litigation Expenses" means costs and expenses incurred in connection with prosecuting and settling the *Spectrum* Action and this Action (which may include the costs and expenses of Lead Plaintiff directly related to its objection to the Prior Settlement in the *Spectrum* Action and its subsequent application to be Lead Plaintiff of the HRG Subclass), for which Lead Counsel intends to apply to the Court for payment from the Settlement Fund.
 - (aa) "Net Settlement Fund" means the Settlement Fund less: (i) any Taxes;

- (ii) any Notice and Administration Costs; (iii) any Litigation Expenses awarded by the Court; (iv) any attorneys' fees awarded by the Court; and (v) any other costs or fees approved by the Court.
- (bb) "Notice" means the Notice of (I) Pendency of Class Action and Proposed Settlement; (II) Settlement Fairness Hearing; and (III) Motion for an Award of Attorneys' Fees and Litigation Expenses, substantially in the form attached hereto as Exhibit 1 to Exhibit A, which is to be mailed to HRG Subclass Members.
- (cc) "Notice and Administration Costs" means the costs, fees, and expenses that are incurred by the Claims Administrator and/or Lead Counsel in connection with: (i) providing notices of the Prior Settlement and the Settlement; and (ii) administering the Prior Settlement and Settlement, including but not limited to the Claims process, as well as the costs, fees, and expenses incurred in connection with the Escrow Account.
- (dd) "Officer" means any officer as that term is defined in Securities and Exchange Act Rule 16a-1(f).
 - (ee) "Old Spectrum" means Spectrum Brands Legacy, Inc.
- (ff) "Parties" means Defendants and Lead Plaintiff, on behalf of itself and the HRG Subclass.
- (gg) "Plaintiffs' Releasees" means (i) Lead Plaintiff, all other HRG Subclass Members, and Plaintiffs' Counsel; (ii) the present and former parents, subsidiaries, divisions, and affiliates of each of the foregoing in (i); (iii) the present and former employees, Officers, directors, and trustees of each of the foregoing in (i)-(ii); (iv) the present and former attorneys, insurers, and agents of each of the foregoing in (i)-(iii); and (v) the predecessors, heirs, successors, and assigns of each of the foregoing in (i)-(iv).

- (hh) "Plan of Allocation" means the proposed plan of allocation of the Net Settlement Fund set forth in the Notice.
- (ii) "Preliminary Approval Order" means the order, substantially in the form attached hereto as Exhibit A, to be entered by the Court preliminarily approving the Settlement and directing that notice of the Settlement be provided to the HRG Subclass.
- (jj) "Prior Settlement" means the prior settlement between the Spectrum Subclass Lead Plaintiffs and Defendants pursuant to the Stipulation and Agreement of Settlement dated August 10, 2020.
- (kk) "PSLRA" means the Private Securities Litigation Reform Act of 1995,15 U.S.C. § 78u-4, as amended.
- (ll) "Released Claims" means all Released Defendants' Claims and all Released Plaintiffs' Claims.
- (mm) "Released Defendants' Claims" means all claims, demand, losses, liabilities, rights, and causes of action of any nature whatsoever, whether known claims or Unknown Claims, whether arising under federal, state, common, or foreign law, whether brought directly or indirectly, that arise out of or relate in any way to the institution, prosecution, or settlement of the claims asserted in the Action against Defendants. Released Defendants' Claims do not include any of the Excluded Defendants' Claims.
- (nn) "Released Plaintiffs' Claims" means all claims, demands, losses, liabilities, rights, and causes of action of any nature whatsoever, whether known claims or Unknown Claims, whether under state, common, or foreign law, whether brought directly or indirectly, that (i) the Spectrum Subclass Lead Plaintiffs asserted on behalf of members of the HRG Subclass in the Complaint or (ii) that Lead Plaintiff or any other members of

the HRG Subclass, on behalf of themselves and their respective successors, assigns, executors, administrators, representatives, attorneys, and agents, in their capacities as such, could have asserted in this Action or could in the future assert in any forum that arise out of, are based upon, or relate to in any way to (a) any of the allegations, acts, transactions, facts, events, matters, occurrences, representations or omissions involved, set forth, alleged, or referred to in the Complaint and (b) the purchase, acquisition, sale, or holding of HRG common stock during the Class Period by members of the HRG Subclass. The Released Plaintiffs' Claims do not include any of the Excluded Plaintiffs' Claims.

- (oo) "Releasee(s)" means each and any of the Defendants' Releasees and each and any of the Plaintiffs' Releasees.
 - (pp) "Releases" means the releases set forth in \P 5-6 of this Stipulation.
- (qq) "Settlement" means the settlement between Lead Plaintiff and Defendants on the terms and conditions set forth in this Stipulation.
 - (rr) "Settlement Amount" means \$7,250,000 in cash.
- (ss) "Settlement Class Period" or "Class Period" means the period from January 26, 2017 to July 13, 2018.
- (tt) "Settlement Fund" means the Settlement Amount plus any and all interest earned thereon.
- (uu) "Settlement Hearing" means the hearing set by the Court under Rule 23(e)(2) of the Federal Rules of Civil Procedure to consider final approval of the Settlement.
 - (vv) "Spectrum" or the "Company" means Spectrum Brands Holdings, Inc.

- (ww) "HRG Subclass" means all persons and entities that purchased common stock of HRG from January 26, 2017 to July 13, 2018, and were damaged thereby. Excluded from the HRG Subclass are: (i) Defendants (including Spectrum); (ii) the Immediate Family members of the Individual Defendants; (iii) the Officers and directors of Old Spectrum, Spectrum, and HRG currently and during either (a) the Class Period; or (b) the Spectrum Class Period and their Immediate Family members; (iv) any entity in which any of the foregoing excluded persons or entities has or had a controlling interest; and (v) the legal representatives, heirs, successors, or assigns of any such excluded person or entity. Also excluded from the HRG Subclass are any persons and entities who or which excluded themselves from the settlement class in connection with the Prior Settlement, or any persons or entities who exclude themselves from the HRG Subclass in connection with this Settlement by submitting a request for exclusion that is accepted by the Court. This Settlement does not settle or release claims arising out of purchases of (i) common stock of Old Spectrum from January 26, 2017 to July 13, 2018; and (ii) common stock of Spectrum from July 13, 2018 to November 19, 2018.
- (xx) "HRG Subclass Member" means each person and entity who or which is a member of the HRG Subclass.
- (yy) "Summary Notice" means the Summary Notice of (I) Pendency of Class Action and Proposed Settlement; (II) Settlement Fairness Hearing; and (III) Motion for an Award of Attorneys' Fees and Litigation Expenses, substantially in the form attached hereto as Exhibit 3 to Exhibit A, to be published as set forth in the Preliminary Approval Order.
 - (zz) "Taxes" means: (i) all federal, state and local taxes of any kind

(including any interest or penalties thereon) on any income earned by the Settlement Fund; and (ii) the expenses and costs incurred by Lead Counsel in connection with determining the amount of, and paying, any taxes owed by the Settlement Fund (including, without limitation, expenses of tax attorneys and accountants).

(aaa) "Unknown Claims" means any Released Plaintiffs' Claims which Lead Plaintiff or any other HRG Subclass Member does not know or suspect to exist in his, her, or its favor at the time of the release of such claims, and any Released Defendants' Claims which any Defendant does not know or suspect to exist in his, her, or its favor at the time of the release of such claims, which, if known by him, her, or it, might have affected his, her, or its decision(s) with respect to this Settlement. With respect to any and all Released Claims, the Parties stipulate and agree that, upon the Effective Date of the Settlement, Lead Plaintiff and Defendants shall expressly waive, and each of the other HRG Subclass Members shall be deemed to have waived, and by operation of the Judgment shall have expressly waived, any and all provisions, rights, and benefits conferred by any law of any state or territory of the United States, or principle of common law or foreign law, which is similar, comparable, or equivalent to California Civil Code §1542, which provides:

A general release does not extend to claims that the creditor or releasing party does not know or suspect to exist in his or her favor at the time of executing the release and that, if known by him or her, would have materially affected his or her settlement with the debtor or released party.

Lead Plaintiff and Defendants acknowledge, and each of the other HRG Subclass Members shall be deemed by operation of law to have acknowledged, that the foregoing waiver was

separately bargained for and a key element of the Settlement.

CLASS CERTIFICATION

2. Solely for purposes of the Settlement and for no other purpose, Defendants stipulate and agree to: (a) certification of the Action as a class action pursuant to Rules 23(a) and 23(b)(3) of the Federal Rules of Civil Procedure on behalf of the HRG Subclass; (b) certification of Lead Plaintiff as Class Representative for the HRG Subclass; and (c) appointment of Lead Counsel as Class Counsel for the HRG Subclass pursuant to Rule 23(g) of the Federal Rules of Civil Procedure.

PRELIMINARY APPROVAL OF SETTLEMENT

3. Promptly upon execution of this Stipulation, Lead Plaintiff will move for preliminary approval of the Settlement, authorization to provide notice of the Settlement to the HRG Subclass, and the scheduling of a hearing for consideration of final approval of the Settlement, which motion shall be unopposed by Defendants. Concurrently with the motion for preliminary approval, Lead Plaintiff shall apply to the Court for, and Defendants shall agree to, entry of the Preliminary Approval Order, substantially in the form attached hereto as Exhibit A.

RELEASE OF CLAIMS

- 4. The obligations incurred pursuant to this Stipulation are in consideration of: (a) the full and final disposition of all Released Plaintiffs' Claims as against Defendants; and (b) the Releases provided for herein.
- 5. Pursuant to the Judgment, without further action by anyone, upon the Effective Date of the Settlement, Lead Plaintiff and each of the other HRG Subclass Members shall be deemed to have, and by operation of law and of the Judgment shall have, fully, finally, and forever compromised, settled, released, resolved, relinquished, waived, and discharged each and every Released

Plaintiffs' Claim against Defendants and the other Defendants' Releasees, and shall forever be barred and enjoined from prosecuting any or all of the Released Plaintiffs' Claims against any of the Defendants' Releasees. This Release shall not apply to any Excluded Plaintiffs' Claim.

- 6. Pursuant to the Judgment, without further action by anyone, upon the Effective Date of the Settlement, Defendants, on behalf of themselves and their respective successors, assigns, executors, administrators, representatives, attorneys, and agents, in their capacities as such, shall be deemed to have, and by operation of law and of the Judgment shall have, fully, finally, and forever compromised, settled, released, resolved, relinquished, waived, and discharged each and every Released Defendants' Claim against Lead Plaintiff and the other Plaintiffs' Releasees, and shall forever be barred and enjoined from prosecuting any or all of the Released Defendants' Claims against any of the Plaintiffs' Releasees. This release shall not apply to any person or entity who or which previously submitted a request for exclusion from the settlement class in connection with the Prior Settlement or any person or entity that submits a request for exclusion from the HRG Subclass that is accepted by the Court. This Release shall not apply to any Excluded Defendants' Claim.
- 7. Notwithstanding ¶¶ 5-6 above, nothing in the Judgment shall bar any action by any of the Parties to enforce or effectuate the terms of this Stipulation or the Judgment.

THE SETTLEMENT CONSIDERATION

8. In consideration of the Settlement of the Released Plaintiffs' Claims against Defendants and the other Defendants' Releasees, Spectrum, on behalf of all Defendants and the other Defendants' Releasees, shall pay or cause to be paid the Settlement Amount into the Escrow Account no later than fifteen (15) business days after the later of (i) preliminary approval of the Settlement by the Court; or (ii) Defendants' Counsel's receipt of a complete IRS Form W-9 and

wire transfer, ACH transfer, and check payment instructions (including contact information and a physical address for the recipient of the Settlement Amount).

USE OF SETTLEMENT FUND

- 9. The Settlement Fund shall be used to pay: (a) any Taxes; (b) any Notice and Administration Costs; (c) any Litigation Expenses awarded by the Court; (d) any attorneys' fees awarded by the Court; and (e) any other costs and fees approved by the Court. The balance remaining in the Settlement Fund, that is, the Net Settlement Fund, shall be distributed to Authorized Claimants as provided in ¶¶ 18-30 below.
- 10. Except as provided herein or pursuant to orders of the Court, the Net Settlement Funds shall remain in the Escrow Account prior to the Effective Date. All funds held by the Escrow Agent shall be deemed to be in the custody of the Court and shall remain subject to the jurisdiction of the Court until such time as the funds shall be distributed or returned pursuant to the terms of this Stipulation and/or further order of the Court. The Escrow Agent shall invest any funds in the Escrow Account exclusively in United States Treasury Bills (or a mutual fund invested solely in such instruments) and shall collect and reinvest all interest accrued thereon, except that any residual cash balances up to the amount that is insured by the FDIC may be deposited in any account that is fully insured by the FDIC. In the event that the yield on United States Treasury Bills is negative, in lieu of purchasing such Treasury Bills, all or any portion of the funds held by the Escrow Agent may be deposited in any account that is fully insured by the FDIC or backed by the full faith and credit of the United States. Additionally, if short-term placement of the funds is necessary, all or any portion of the funds held by the Escrow Agent may be deposited in any account that is fully insured by the FDIC or backed by the full faith and credit of the United States.
- 11. The Parties agree that the Settlement Fund is intended to be a Qualified SettlementFund

within the meaning of Treasury Regulation § 1.468B-1 and that Lead Counsel, as administrator of the Settlement Fund within the meaning of Treasury Regulation § 1.468B-2(k)(3), shall be solely responsible for filing or causing to be filed all informational and other tax returns as may be necessary or appropriate (including, without limitation, the returns described in TreasuryRegulation § 1.468B-2(k)) for the Settlement Fund. Lead Counsel shall also be responsible for causing payment to be made from the Settlement Fund of any Taxes owed with respect to the Settlement Fund. The Defendants' Releasees shall not have any liability or responsibility for anysuch Taxes. Upon written request, Defendants will provide to Lead Counsel the statement described in Treasury Regulation § 1.468B-3(e). Lead Counsel, as administrator of the SettlementFund within the meaning of Treasury Regulation § 1.468B-2(k)(3), shall timely make such elections as are necessary or advisable to carry out this paragraph, including, as necessary, makinga "relation back election," as described in Treasury Regulation § 1.468B-1(j), to cause the Qualified Settlement Fund to come into existence at the earliest allowable date, and shall take or cause to be taken all actions as may be necessary or appropriate in connection therewith.

- 12. All Taxes shall be paid out of the Settlement Fund, and shall be timely paid, or caused to be paid, by Lead Counsel and without further order of the Court. Any tax returns prepared for the Settlement Fund (as well as the election set forth therein) shall be consistent withthe previous paragraph and in all events shall reflect that all Taxes on the income earned by the Settlement Fund shall be paid out of the Settlement Fund as provided herein. Defendants' Releasees shall have no responsibility or liability for the acts or omissions of Lead Counsel or itsagents with respect to the payment of Taxes, as described herein.
- 13. The Settlement is not a claims-made settlement. Upon the occurrence of the Effective Date, no Defendant, Defendants' Releasee, or any other person or entity who or which paid any portion

of the Settlement Amount shall have any right to the return of the Settlement Fund or any portion thereof for any reason whatsoever, including without limitation, the number of Claims submitted, the collective amount of Recognized Claims of Authorized Claimants, the percentage of recovery of losses, or the amounts to be paid to Authorized Claimants from the Net Settlement Fund.

14. Notwithstanding the fact that the Effective Date of the Settlement has not yet occurred, Lead Counsel may pay up to \$500,000 from the Settlement Fund, without further approval from Defendants or further order of the Court, for Notice and Administration Costs actually incurred and paid or payable. Such costs and expenses shall include, without limitation, costs associated with the actual costs of printing and mailing the Notice, publishing the Summary Notice, reimbursements to nominee owners for forwarding the Notice to their beneficial owners, the administrative expenses incurred and fees charged by the Claims Administrator in connection with providing notice and administering the Settlement (including processing the Claims submitted in connection with this Settlement or the Prior Settlement), and the fees, if any, of the Escrow Agent. In the event that the Settlement is terminated pursuant to the terms of this Stipulation, all Notice and Administration Costs paid or incurred, including any related fees, shall not be returned or repaid to Defendants, any of the other Defendants' Releasees, or any other person or entity who or which paid any portion of the Settlement Amount.

ATTORNEYS' FEES AND LITIGATION EXPENSES

15. Lead Counsel will apply to the Court for a collective award of attorneys' fees to Lead Counsel to be paid solely from (and out of) the Settlement Fund. Lead Counsel also will apply to the Court for an award of Litigation Expenses, which may include a request for reimbursement of Lead Plaintiff's costs and expenses directly related to their representation of the HRG Subclass, to be paid solely from (and out of) the Settlement Fund. Lead Counsel's application for an award of

attorneys' fees and Litigation Expenses is not the subject of any agreement between Defendants and Lead Plaintiffs other than what is set forth in this Stipulation.

16. Any attorneys' fees and Litigation Expenses that are awarded by the Court shall be paid to Lead Counsel immediately upon award, notwithstanding the existence of any timely filed objections thereto, or potential for appeal therefrom, or collateral attack on the Settlement or any part thereof, subject to Lead Counsel's obligation to make appropriate refunds or repayments to the Settlement Fund, plus accrued interest at the same net rate as is earned by the Settlement Fund, if the Settlement is terminated pursuant to the terms of this Stipulation or if, as a result of any appeal or further proceedings on remand, or successful collateral attack, the award of attorneys' fees and Litigation Expenses is reduced or reversed and such order reducing or reversing the award has become Final. Lead Counsel shall make the appropriate refund or repayment in full no later than thirty (30) calendar days after: (a) receiving from Defendants' Counsel notice of the termination of the Settlement; or (b) any order reducing or reversing the award of attorneys' fees and Litigation Expenses has become Final. An award of attorneys' fees and Litigation Expenses is not a necessary term of this Stipulation and is not a condition of the Settlement embodied herein. Neither Lead Plaintiff nor Lead Counsel may cancel or terminate the Settlement based on this Court's or any appellate court's ruling with respect to attorneys' fees and Litigation Expenses.

NOTICE AND SETTLEMENT ADMINISTRATION

17. As part of the Preliminary Approval Order, Lead Counsel shall seek appointment of a Claims Administrator. The Claims Administrator shall administer the Settlement, including but not limited to the process of receiving, reviewing, and approving or denying Claims, under Lead Counsel's supervision and subject to the jurisdiction of the Court. None of the Defendants, nor any other Defendants' Releasees, shall have any involvement in or any responsibility, authority, or

liability whatsoever for the selection of the Claims Administrator, the Plan of Allocation, the administration of the Settlement, the Claims process, or disbursement of the Net Settlement Fund, and shall have no liability whatsoever to any person or entity, including, but not limited to, Lead Plaintiff, any other HRG Subclass Members, or Lead Counsel in connection with the foregoing. Defendants' Counsel shall cooperate in the administration of the Settlement to the extent reasonably necessary to effectuate its terms.

- 18. In accordance with the terms of the Preliminary Approval Order to be entered by the Court, Lead Counsel shall cause the Claims Administrator to mail the Notice and Proof of Claim Form to those members of the HRG Subclass as may be identified through reasonable effort. Lead Counsel shall also cause the Claims Administrator to have the Summary Notice published in accordance with the terms of the Preliminary Approval Order to be entered by the Court.
- 19. No later than ten (10) calendar days following the filing of this Stipulation with the Court, Defendants shall serve any notice required under the Class Action Fairness Act, 28 U.S.C. § 1715 *et seq.* ("CAFA"). Defendants are solely responsible for the costs of the CAFA notice and administering the CAFA notice. At least seven (7) calendar days before the Settlement Hearing, Defendants shall cause to be served on Lead Counsel and filed with the Court proof, by affidavit or declaration, regarding compliance with CAFA § 1715(b).
- 20. HRG Subclass Members who wish to be eligible for a payment from the Net Settlement Fund must submit a Claim Form by the date set forth in the Preliminary Approval Order. However, HRG Subclass Members who previously submitted a claim form inconnection with the Prior Settlement will not be required to submit a new Claim Form. The information those Claimants previously submitted will be used to calculate their claim for this Settlement. The Claims Administrator shall receive Claims and determine first, whether the Claimis a valid Claim, in whole

or part, and second, each Authorized Claimant's *pro rata* share of the Net Settlement Fund based upon each Authorized Claim compared to the total Recognized Claims of all Authorized Claimants (as set forth in the Plan of Allocation set forth in the Notice attached hereto as Exhibit 1 to Exhibit A, or in such other plan of allocation as the Court approves).

- 21. The Plan of Allocation proposed in the Notice is not a necessary term of the Settlement or of this Stipulation and it is not a condition of the Settlement or of this Stipulation that any particular plan of allocation be approved by the Court. Lead Plaintiffs and Lead Counselmay not cancel or terminate the Settlement (or this Stipulation) based on this Court's or any appellate court's ruling with respect to the Plan of Allocation or any other plan of allocation in this Action. Defendants and the other Defendants' Releasees shall not object in any way to the Plan of Allocation or any other plan of allocation in this Action. No Defendant, nor any other Defendants' Releasees, shall have any involvement with or liability, obligation, or responsibility whatsoever for the application of the Court-approved plan of allocation.
- 22. Any HRG Subclass Member who does not submit a valid Claim will not be entitled to receive any distribution from the Net Settlement Fund, but will otherwise be bound by all of the terms of this Stipulation and the Settlement, including the terms of the Judgment to be entered in the Action and the Releases provided for herein and therein, and will be permanently barred and enjoined from bringing any action, claim, or other proceeding of any kind against the Defendants' Releasees with respect to the Released Plaintiffs' Claims in the event that the Effective Date occurs with respect to the Settlement.
- 23. Lead Counsel shall be responsible for supervising the administration of the Settlement and the disbursement of the Net Settlement Fund subject to Court approval. No Defendant, or any other Defendants' Releasees, shall be permitted to review, contest, or object to any Claim, or any

decision of the Claims Administrator or Lead Counsel with respect to accepting or rejecting any Claim for payment. Lead Counsel shall have the right, but not the obligation, to waive what it deems to be formal or technical defects in any Claims submitted in the interests of achieving substantial justice.

- 24. For purposes of determining the extent, if any, to which an HRG Subclass Member shall be entitled to be treated as an Authorized Claimant, the following conditions shall apply:
 - (a) Each Claimant shall be required to submit a Claim in paper form, substantially in the form attached hereto as Exhibit 2 to Exhibit A, or in electronic form, in accordance with the instructions for the submission of such Claims, and supported by such documents as are designated therein, including proof of the Claimant's loss, or such other documents or proof as the Claims Administrator or Lead Counsel, in their discretion, may deem acceptable. Claimants who previously submitted a claim form in connection with the Prior Settlement will not be required to submit a new Claim Form. The information those Claimants previously submitted will be used to calculate their claim for this Settlement;
 - (b) All Claims must be submitted by the date set by the Court in the Preliminary Approval Order and specified in the Notice. Any HRG Subclass Member who fails to submita Claim by such date shall be forever barred from receiving any distribution from the Net Settlement Fund or payment pursuant to this Stipulation (unless by Order of the Court such HRG Subclass Member's Claim is accepted), but shall in all other respects be bound by all of the terms of this Stipulation and the Settlement, including the terms of the Judgment and the Releases provided for herein and therein, and will be permanently barred and enjoined from bringing any action, claim, or other proceeding of any kind against any Defendants' Releasees with respect to any Released Plaintiffs' Claim. Provided

that it is mailed by the claim-submission deadline, a Claim Form shall be deemed to be submitted when postmarked, if received with a postmark indicated on the envelope and if mailed by first-class mail and addressed in accordance with the instructions thereon. In all other cases, the Claim Form shall be deemed to have been submitted on the date when actually received by the Claims Administrator;

- (c) Each Claim shall be submitted to and reviewed by the Claims Administrator, who shall determine in accordance with this Stipulation and the plan of allocation the extent, if any, to which each Claim shall be allowed, subject to review by the Court pursuant to subparagraph (e) below as necessary;
- (d) Claims that do not meet the submission requirements may be rejected. Priorto rejecting a Claim in whole or in part, the Claims Administrator shall communicate with the Claimant in writing, to give the Claimant the chance to remedy any curable deficiencies in the Claim submitted. The Claims Administrator shall notify, in a timely fashion and in writing, all Claimants whose Claim the Claims Administrator proposes to reject in whole or in part, setting forth the reasons therefor, and shall indicate in such notice that the Claimant whose Claim is to berejected has the right to a review by the Court if the Claimant so desires and complies with the requirements of subparagraph (e) below; and
- (e) If any Claimant whose Claim has been rejected in whole or in part desires tocontest such rejection, the Claimant must, within twenty (20) calendar days after the date of mailing of the notice required in subparagraph (d) above or a lesser time period if the Claim was untimely, serve upon the Claims Administrator a notice and statement of reasons indicating the Claimant's grounds for contesting the rejection along with any

supporting documentation, and requesting a review thereof by the Court. If a dispute concerning a Claim cannot be otherwise resolved, Lead Counsel shall thereafter present the request for review to the Court.

- 25. Each Claimant shall be deemed to have submitted to the jurisdiction of the Court with respect to the Claimant's Claim, and the Claim will be subject to investigation and discovery under the Federal Rules of Civil Procedure, provided, however, that such investigation and discovery shall be limited to that Claimant's status as an HRG Subclass Member and the validity and amount of the Claimant's Claim. No discovery shall be allowed on the merits of this Action or of the Settlement in connection with the processing of Claims.
- 26. Lead Counsel will apply to the Court, on notice to Defendants' Counsel, for a Class Distribution Order: (a) approving the Claims Administrator's administrative determinations concerning the acceptance and rejection of the Claims submitted; (b) approving payment of any administration fees and expenses associated with the administration of the Settlement from the Escrow Account; and (c) if the Effective Date has occurred, directing payment of the Net Settlement Fund to Authorized Claimants from the Escrow Account.
- 27. Payment pursuant to the Class Distribution Order shall be final and conclusive against all Claimants. All HRG Subclass Members whose Claims are not approved by the Court for payment shall be barred from participating in distributions from the Net Settlement Fund, but otherwise shall be bound by all of the terms of this Stipulation and the Settlement, including the terms of the Judgment to be entered in this Action and the Releases provided for herein and therein, and will be permanently barred and enjoined from bringing any action against any and all Defendants' Releasees with respect to any and all of the Released Plaintiffs' Claims.
- 28. No person or entity shall have any claim against Lead Plaintiff, Lead Counsel, the Claims

Administrator, or any other agent designated by Lead Counsel, or Defendants' Releasees or their respective counsel, arising from distributions made substantially in accordance with the Stipulation, the plan of allocation approved by the Court, or any order of the Court. Lead Plaintiffs and Defendants, and their respective counsel, and Lead Plaintiff's damages expert and all other Releasees shall have no liability whatsoever for the investment or distribution of the Settlement Fund or the Net Settlement Fund, the plan of allocation, or the determination, administration, calculation, or payment of any claim or nonperformance of the Claims Administrator, the payment or withholding of taxes (including interest and penalties) owed by the Settlement Fund, or any losses incurred in connection therewith.

29. All proceedings with respect to the administration, processing, and determination of Claims and the determination of all controversies relating thereto, including disputed questions of law and fact with respect to the validity of Claims, shall be subject to the jurisdiction of the Court. All HRG Subclass Members, other Claimants, and Parties to this Settlement expressly waive trial by jury (to the extent any such right may exist) and any right of appeal or review with respect to such determinations.

TERMS OF THE JUDGMENT

30. If the Settlement contemplated by this Stipulation is approved by the Court, Lead Counsel and Defendants' Counsel shall request that the Court enter a Judgment, substantially in the form attached hereto as Exhibit B.

CONDITIONS OF SETTLEMENT AND EFFECT OF DISAPPROVAL, CANCELLATION OR TERMINATION

- 31. The Effective Date of the Settlement shall be deemed to occur on the occurrence or waiver of all of the following events:
 - (a) the Court has entered the Preliminary Approval Order,

substantially in the form set forth in Exhibit A attached hereto, as required by ¶ 3 above;

- (b) the Settlement Amount has been deposited into the Escrow Account in accordance with the provisions of ¶ 8 above;
- (c) Spectrum has not exercised its option to terminate the Settlement pursuant to the provisions of this Stipulation;
- (d) Lead Plaintiff has not exercised its option to terminate the Settlement pursuant to the provisions of this Stipulation; and
- (e) the Court has approved the Settlement as described herein, following notice to the HRG Subclass and a hearing, as prescribed by Rule 23 of the Federal Rules of Civil Procedure, and entered the Judgment, and the Judgment has become Final.
- 32. Upon the occurrence of all of the events referenced in ¶ 31 above, all remaining interest or right of Defendants in or to the Settlement Fund, if any, shall be absolutely and forever extinguished, and the Releases herein shall be effective.
- 33. If (i) Spectrum exercises its right to terminate the Settlement as provided in this Stipulation; (ii) Lead Plaintiff exercises its right to terminate the Settlement as provided in this Stipulation; (iii) the Court disapproves the Settlement; or (iv) the Effective Date as to the Settlement otherwise fails to occur, then:
 - (a) The Settlement and the relevant portions of this Stipulation shall be canceled and terminated.
 - (b) Lead Plaintiff and Defendants shall revert to their respective positions in the Action as of immediately prior to the execution of the Term Sheet on September 20, 2021.

- (c) The terms and provisions of this Stipulation, with the exception of this ¶ 33 and ¶¶ 14, 16, 37, and 57 of this Stipulation, shall have no further force and effect with respect to the Parties and shall not be used in the Action or in any other proceeding for any purpose, and any Judgment or order entered by the Court in accordance with the terms of this Stipulation shall be treated as vacated, *nunc pro tunc*.
- (d) Within thirty (30) calendar days after joint written notification of terminationis sent by Defendants' Counsel and Lead Counsel to the Escrow Agent, the Settlement Fund (including accrued interest thereon, any change in value as a result of the investment of the Settlement Fund, and any funds received by Lead Counsel consistent with ¶ 16 above), less any Notice and Administration Costs actually incurred, paid, or payable and less any Taxes paid, due,or owing shall be refunded by the Escrow Agent to Spectrum (or such other persons or entities as Spectrum may direct). In the event that the funds received by Lead Counsel consistent with ¶ 16 above have not been refunded to the Settlement Fund within the thirty (30) calendar days specified in this paragraph, those funds shall be refunded by the Escrow Agent to Spectrum (or such other persons or entities as Spectrum may direct) immediately upon their deposit into the Escrow Account consistent with ¶ 16 above.
- 34. It is further stipulated and agreed that Spectrum and Lead Plaintiff shall each have the right to terminate the Settlement and this Stipulation, by providing written notice of their election to do so ("Termination Notice") to the other Parties to this Stipulation within thirty (30) calendar days of: (a) the Court's final refusal to enter the Preliminary Approval Order in any material respect; (b) the Court's final refusal to approve the Settlement or any material part thereof; (c) the Court's final refusal to enter the Judgment in any material respect as to the Settlement; or (d) the date upon

which the Judgment is modified or reversed in any material respect by the United States Court of Appeals for the Seventh Circuit or the United States Supreme Court, and the provisions of ¶ 33 above shall apply. However, any decision or proceeding, whether in this Court or any appellate court, with respect to an application for attorneys' fees or payment of Litigation Expenses or with respect to any plan of allocation shall not be considered material to the Settlement, shall not affect the finality of any Judgment, and shall not be grounds for termination of the Settlement.

35. In addition to the grounds set forth in ¶ 34 above, Spectrum shall have the unilateral right to terminate the Settlement in the event that HRG Subclass Members timely and validly requesting exclusion from the HRG Subclass meet the conditions set forth in Spectrum's confidential supplemental agreement with Lead Plaintiff (the "Supplemental Agreement"), in accordance with the terms of that agreement. The Supplemental Agreement, which is being executed concurrently herewith, shall not be filed with the Court and its terms shall not be disclosed in any other manner (other than the statements herein and in the Notice, to the extent necessary, or as otherwise provided in the Supplemental Agreement) unless the Court otherwise directs or a dispute arises between Lead Plaintiff and Spectrum concerning its interpretation or application, in which event the Parties shall submit the Supplemental Agreement to the Court in camera and request that the Court afford it confidential treatment. Lead Counsel and Spectrum's Counsel shall jointly request that the deadline for submitting requests for exclusion from the HRG Subclass be no later than twenty-one (21) calendar days prior to the Settlement Fairness Hearing. Copies of all requests for exclusion from the HRG Subclass received by the Claims Administrator (or other person designated to receive exclusion requests) shall be provided to Spectrum's Counsel no later than fourteen (14) calendar days prior to the Settlement Fairness Hearing. To be valid for purposes of the Supplemental Agreement, a request for exclusion must be timely and contain all of the

information requested in the Notice.

36. In addition to the grounds set forth in ¶ 34 above, Lead Plaintiff shall also have the right to terminate the Settlement in the event that the Settlement Amount has not been paid as provided for in ¶ 8 above, by providing written notice of the election to terminate to Defendants' Counsel.

NO ADMISSION OF WRONGDOING

- 37. Neither the Term Sheet, this Stipulation (whether or not consummated), including the exhibits hereto and the Plan of Allocation contained therein (or any other plan of allocation that may be approved by the Court), the negotiations leading to the execution of the Term Sheet and this Stipulation, nor any proceedings taken pursuant to or in connection with the Term Sheet, this Stipulation, or approval of the Settlement (including any arguments proffered in connection therewith):
 - evidence of, orconstrued as, or deemed to be evidence of any presumption, concession, or admission by any of the Defendants' Releasees with respect to the truth of any fact alleged by the HRG Subclass Lead Plaintiffs or Lead Plaintiff or the validity of any claim that was or could have been asserted or the deficiency of any defense that has been or could have been asserted in this Action or the *Spectrum* Action or in any other litigation, or of any liability, negligence, fault, or other wrongdoing of any kind of any of the Defendants' Releasees or in any way referred to for any other reason as against any of the Defendants' Releasees, in any arbitrationproceeding or other civil, criminal, or administrative action or proceeding, other than such proceedings as may be necessary to effectuate the provisions of this Stipulation; any liability, negligence, fault, or wrongdoing of any kind, or in any way referred to for any other reason as against any of the Plaintiffs' Releasees, in any

arbitration proceeding or other civil, criminal, or administrative actionor proceeding, other than such proceedings as may be necessary to effectuate the provisions of this Stipulation; or

- (b) shall be offered against any of the Plaintiffs' Releasees, as evidence of, or construed as, or deemed to be evidence of any presumption, concession, or admission by any of the Plaintiffs' Releasees that any of their claims are without merit, that any of the Defendants' Releasees had meritorious defenses, or that damages recoverable under the Complaint would not have exceeded the Settlement Amount or with respect to any liability, negligence, fault, or wrongdoing of any kind, or in any way referred to for any other reason as against any of the Plaintiffs' Releasees, in any arbitration proceeding or other civil, criminal, or administrative action or proceeding, other than such proceedings as may be necessary to effectuate the provisions of this Stipulation; or
- (c) shall be construed against any of the Releasees as an admission, concession, or presumption that the consideration to be given hereunder represents the amount which could be would have been recovered after trial; *provided*, *however*, that if this Stipulation is approved by the Court, the Parties and the Releasees and their respective counsel may refer to it to effectuate the protections from liability granted hereunder or otherwise to enforce the terms of the Settlement.

MISCELLANEOUS PROVISIONS

38. All of the exhibits attached hereto are hereby incorporated by reference as though fully set forth herein. Notwithstanding the foregoing, in the event that there exists a conflict or inconsistency between the terms of this Stipulation and the terms of any exhibit attached hereto, the terms of the Stipulation shall prevail.

- 39. Defendants warrant that, as to the payments made or to be made on behalf of them, at the time of entering into this Stipulation and at the time of such payment they, or to the best of their knowledge any persons or entities contributing to the payment of the Settlement Amount, were not insolvent, nor will the payment required to be made by or on behalf of them render them insolvent, within the meaning of or for the purposes of the United States Bankruptcy Code, including §§ 101 and 547 thereof. This representation is made by each of the Defendants and not by their counsel.
- 40. In the event of the entry of a final order of a court of competent jurisdiction determining the transfer of money to the Settlement Fund or any portion thereof by or on behalf of Defendants to be a preference, voidable transfer, fraudulent transfer, or similar transaction and portion thereof is required to be returned, and such amount is not promptly deposited into the Settlement Fund by others, then, at the election of Lead Plaintiff, Lead Plaintiff and Defendants shall jointly move the Court to vacate and set aside the Releases given and the Judgment entered in favor of Defendants and the other Releasees pursuant to this Stipulation, in which event the Releases and Judgment shall be null and void, and the Parties shall be restored to their respective positions in the litigation as provided in ¶ 33 above and any cash amounts in the Settlement Fund (less any Taxes paid, due, or owing with respect to the Settlement Fund and less any Notice and Administration Costs actually incurred, paid, or payable) shall be returned as provided in ¶ 33 above.
- 41. The Parties intend this Stipulation and the Settlement to be a final and complete resolution of all disputes asserted or which could be asserted by Lead Plaintiff and any other HRG Subclass Members against the Defendants' Releasees with respect to the Released Plaintiffs' Claims. No Party shall assert any claims of any violation of Rule 11 of the Federal Rules of Civil Procedure relating to the institution, prosecution, defense, or settlement of this Action by the Parties. The

Parties agree that the amounts paid and the other terms of the Settlementwere negotiated at arm's length and in good faith by the Parties and reflect the Settlement that wasreached voluntarily after extensive negotiations and consultation with experienced legal counsel, who were fully competent to assess the strengths and weaknesses of their respective clients' claims or defenses.

- 42. While retaining their right to deny that the claims asserted in the Action were meritorious, Defendants and their counsel, in any statement made to any media representative (whether or not for attribution) will not assert that the Action was commenced or prosecuted in bad faith, nor will they deny that the Action was commenced and prosecuted in good faith and is being settled voluntarily after consultation with competent legal counsel. In all events, Lead Plaintiff and its counsel and Defendants and their counsel shall not make any accusations of wrongful or actionable conduct by any Party concerning the prosecution, defense, and resolution of the Action, and shall not otherwise suggest that the Settlement constitutes an admission of any claim or defense alleged.
- 43. The terms of the Settlement, as reflected in this Stipulation, may not be modified or amended, nor may any of its provisions be waived except by a writing signed on behalf of both Lead Plaintiff and Defendants (or their successors-in-interest).
- 44. The headings herein are used for the purpose of convenience only and are not meant to have legal effect.
- 45. The administration and consummation of the Settlement as embodied in this Stipulation shall be under the authority of the Court, and the Court shall retain jurisdiction for the purpose of entering orders providing for awards of attorneys' fees and Litigation Expenses to Lead Plaintiff and enforcing the terms of this Stipulation, including the Plan of Allocation (or such other plan of allocation as may be approved by the Court) and the distribution of the Net Settlement Fund to HRG Subclass Members.

- 46. The waiver by one Party of any breach of this Stipulation by any other Party shall not be deemed a waiver of any other prior or subsequent breach of this Stipulation.
- 47. This Stipulation and its exhibits and the Supplemental Agreement constitute the entire agreement among Lead Plaintiff and Defendants concerning the Settlement and this Stipulation and its exhibits and the Supplemental Agreement. All Parties acknowledge that no other agreements, representations, warranties, or inducements have been made by any Party hereto concerning this Stipulation, its exhibits, or the Supplemental Agreement other than those contained and memorialized in such documents.
- 48. This Stipulation may be executed in one or more counterparts, including by signature transmitted via facsimile, or by a .pdf/.tif image of the signature transmitted via email. All executed counterparts and each of them shall be deemed to be one and the same instrument.
- 49. This Stipulation shall be binding upon and inure to the benefit of the successors and assigns of the Parties, including any and all Releasees and any corporation, partnership, or other entity into or with which any Party hereto may merge, consolidate, or reorganize.
- 50. The construction, interpretation, operation, effect, and validity of this Stipulation, the Supplemental Agreement, and all documents necessary to effectuate them shall be governed by the internal laws of the State of Wisconsin without regard to conflicts of laws, except to the extent that federal law requires that federal law govern.
- 51. Any action arising under or to enforce this Stipulation or any portion thereof, shall be commenced and maintained only in the Court.
- 52. This Stipulation shall not be construed more strictly against one Party than anothermerely by virtue of the fact that it, or any part of it, may have been prepared by counsel for one of the Parties, it being recognized that it is the result of arm's-length negotiations between the Parties and

all Parties have contributed substantially and materially to the preparation of this Stipulation.

All counsel and any other person executing this Stipulation and any of the exhibitshereto, 53.

or any related Settlement documents, warrant and represent that they have the full authority to do so

and that they have the authority to take appropriate action required or permitted to be taken

pursuant to the Stipulation to effectuate its terms.

54. Lead Counsel and Defendants' Counsel agree to cooperate fully with one another in

seeking Court approval of the Preliminary Approval Order and the Settlement, as embodied in this

Stipulation, and to use best efforts to promptly agree upon and execute all such other

documentation as may be reasonably required to obtain final approval by the Court of the

Settlement.

55. If any Party is required to give notice to another Party under this Stipulation, such notice

shall be in writing and shall be deemed to have been duly given upon receipt of hand delivery or

facsimile or email transmission, with confirmation of receipt. Notice shall be provided as follows:

- 58. All agreements made and orders entered during the course of this Action and the *Spectrum* Action relatingto the confidentiality of information shall survive this Settlement.
- 59. No opinion or advice concerning the tax consequences of the proposed Settlement to individual HRG Subclass Members is being given or will be given by the Parties or their counsel; nor is any representation or warranty in this regard made by virtue of this Stipulation. Each HRG Subclass Member's tax obligations, and the determination thereof, are the sole responsibility of the HRG Subclass Member, and it is understood that the tax consequences may vary depending on the particular circumstances of each individual HRG Subclass Member.

[PROPOSED] ORDER PRELIMINARILY APPROVING SETTLEMENT AND AUTHORIZING DISSEMINATION OF NOTICE OF SETTLEMENT

WHEREAS, a consolidated securities class action is pending in this Court entitled *In re Spectrum Brands Securities Litigation*, No. 19-cv-347-jdp (the "*Spectrum* Action");

WHEREAS, on August 27, 2021, the Court entered an Order severing the claims of purchasers of HRG Group, Inc. ("HRG") common stock during the Class Period in the *Spectrum* Action from the claims of purchasers of Spectrum and Old Spectrum common stock during the Class Period that continue in the *Spectrum* Action;

WHEREAS, on August 31, 2021, pursuant to the August 27, 2021 Order, the Court created the action entitled *Jet Capital Master Fund, L.P. v. HRG Group, Inc.*, No. 21-cv-552-jdp, for claims of purchasers of HRG common stock during the Class Period to continue and this action is referred to herein as the "Action";

WHEREAS, (a) Lead Plaintiff Jet Capital Master Fund, L.P. ("Jet Capital" or "Lead Plaintiff"), on behalf of itselfand the HRG Subclass (defined below); and (b) defendants Spectrum Brands Holdings, Inc. ("Spectrum" or the "Company"), Spectrum Brands Legacy, Inc. ("Old Spectrum"), HRG, and Andreas R. Rouvé, David M. Maura, and Douglas L. Martin (collectively, the "Individual Defendants" and, together with Spectrum, Old Spectrum, and HRG, "Defendants")

(Lead Plaintiff and Defendants, together, the "Parties"), have determined to settle and dismiss with prejudice all claims asserted in this Action on behalf of the HRG Subclass on the terms and conditions set forth in the Stipulation and Agreement of Settlement, dated October 8, 2021 (the "Stipulation"), subject to approval of this Court (the "Settlement");

WHEREAS, Lead Plaintiff has moved, pursuant to Rule 23(e)(1) of the Federal Rules of Civil Procedure, for an order preliminarily approving the Settlement in accordance with the Stipulation and allowing notice to HRG Subclass Members as more fully described herein;

WHEREAS, the Court has read and considered: (a) Lead Plaintiff's motion for preliminary approval of the Settlement and authorization to send notice of the Settlement to the HRG Subclass, and the papers filed and arguments made in connection therewith; and (b) the Stipulation and the exhibits attached thereto; and

WHEREAS, unless otherwise defined herein, all capitalized words contained herein shall have the same meanings as they have in the Stipulation;

NOW THEREFORE, IT IS HEREBY ORDERED:

1. Proposed Class Certification for Settlement Purposes – The Parties have proposed the certification of the following HRG Subclass pursuant to Rule 23(a) and (b)(3) of the Federal Rules of Civil Procedure and solely for purposes of effectuating the proposed Settlement: all persons and entities that purchased common stock of HRG from January 26, 2017 to July 13, 2018 (the "Class Period"), and were damaged thereby. Excluded from the Spectrum Subclass are: (i) Defendants (including Spectrum); (ii) the Immediate Family members of the Individual Defendants; (iii) the Officers and directors of Old Spectrum, Spectrum, and HRG currently and during the period from January 26, 2017 to November 19, 2018 and their Immediate Family members; (iv) any entity in which any of the foregoing excluded persons or entities has or had a controlling interest; and (v) the

legal representatives, heirs, successors, or assigns of any such excluded person or entity. Also excluded from the HRG Subclass are any persons and entities who or which excluded themselves from the settlement class in connection with the Prior Settlement. This Settlement does not settle or release claims arising out of purchases of (i) common stock of Old Spectrum from January 26, 2017 to July 13, 2018; and/or (ii) common stock of Spectrum from July 13, 2018 to November 19, 2018.

- 2. Class Findings The Court finds, pursuant to Rule 23(e)(1)(B)(ii) of the Federal Rules of Civil Procedure, that it will likely be able to certify the HRG Subclass for purposes of the proposed Settlement. Specifically, and solely for purposes of the proposed Settlement of this Action, the Court finds that each element required for certification of the HRG Subclass pursuant to Rule 23 of the Federal Rules of Civil Procedure has been met or will likely be met: (a) the members of the HRG Subclass are so numerous that their joinder in the Action would be impracticable; (b) there are questions of law and fact common to the HRG Subclass which predominate over any individual questions; (c) the claims of Lead Plaintiff in the Action are typical of the claims of the Spectrum Subclass; (d) Lead Plaintiff and Lead Counsel have and will fairly and adequately represent and protect the interests of the HRG Subclass; and (e) a class action is superior to other available methods for the fair and efficient adjudication of the Action.
- 3. The Court also finds, pursuant to Rule 23(e)(1)(B)(ii) of the Federal Rules of Civil Procedure, and for the purposes of the Settlement only, that it will likely be able to certify Lead Plaintiff Jet Capital as Class Representative for the HRG Subclass and appoint Lead Counsel Rolnick Kramer Sadighi LLP as Class Counsel for the HRG Subclass pursuant to Rule 23(g) of the Federal Rules of Civil Procedure.
- 4. **Preliminary Approval of the Settlement** The Court hereby preliminarily approves the

Settlement, as embodied in the Stipulation, and finds, pursuant to Rule 23(e)(1)(B)(i) of the Federal Rules of Civil Procedure, that it will likely be able to finally approve the Settlement under Rule 23(e)(2) as being fair, reasonable, and adequate to the HRG Subclass, subject to further consideration at the Settlement Fairness Hearing to be conducted as described below.

- 5. **Settlement Fairness Hearing** – The Court will hold a hearing (the "Settlement Fairness Hearing") on , 2022 at : .m., either in person at the United States District Court for the Western District of Wisconsin, Courtroom 260, United States Courthouse, 120 North Henry Street, Madison, WI 53703400, or by telephone or video conference (in the discretion of the Court), for the following purposes: (a) to determine whether the proposed Settlement on the terms and conditions provided for in the Stipulation is fair, reasonable, and adequate to the HRG Subclass, and should be finally approved by the Court; (b) to determine whether, for purposes of the Settlement only, the Action should be certified as a class action on behalf of the HRG Subclass, Lead Plaintiff should be certified as Class Representative for the HRG Subclass, and Lead Counsel should be appointed as Class Counsel for the HRG Subclass; (c) to determine whether a Judgment substantially in the form attached as Exhibit B to the Stipulation should be entered dismissing the claims asserted in the Action on behalf of the HRG Subclass with prejudice against Defendants; (d) to determine whether the proposed Plan of Allocation for the proceeds of the Settlement is fair and reasonable and should be approved; (e) to determine whether the motion by Lead Counsel for an award of attorneys' fees and Litigation Expenses should be approved; and (f) to consider any other matters that may properly be brought before the Court in connection with the Settlement. Notice of the Settlement and the Settlement Fairness Hearing shall be given to HRG Subclass Members as set forth in paragraph 7 of this Order.
- 6. The Court may adjourn the Settlement Fairness Hearing without further notice to the HRG

Subclass, and may approve the proposed Settlement with such modifications as the Parties may agree to, if appropriate, without further notice to the HRG Subclass. The Court may decide to hold the Settlement Fairness Hearing by telephone or video conference without further mailed notice to the HRG Subclass. If the Court orders that the Settlement Fairness Hearing be conducted telephonically or by video conference, that decision will be posted on a website to be developed for the Settlement as referenced in paragraph 7(b) of this Order. Any HRG Subclass Member (or his, her, or its counsel) who wishes to appear at the Settlement Fairness Hearing should consult the Court's docket and/or the settlement website for any change in date, time, or format of the hearing.

- Retention of Claims Administrator and Manner of Giving Notice Lead Counsel is hereby authorized to retain JND Legal Administration ("JND" or the "Claims Administrator") to supervise and administer the notice procedure in connection with the proposed Settlement as well as the processing of Claims as more fully set forth below. JND had previously been retained to supervise and administer the notice procedure and claims processing for the Prior Settlement between the Spectrum Subclass Lead Plaintiffs and Defendants. Notice of the Settlement and the Settlement Fairness Hearing shall be given by Lead Counsel as follows:
- (a) beginning not later than fifteen (15) business days after the date of entry of this Order (such date that is fifteen (15) business days after the date of entry of this Order, the "Notice Date"), the Claims Administrator shall cause a copy of the Notice and the Claim Form, substantially in the forms attached hereto as Exhibits 1 and 2, respectively (the "Notice Packet"), to be mailed by first-class mail or emailed to potential HRG Subclass Members at the addresses set forth in the records provided by Defendants or in the records which Defendants caused to be provided in connection with the Prior Settlement; to those

potential HRG Subclass Members previously identified by brokers and nominees in connection with the Prior Settlement or who previously submitted Claim Forms in connection with the Prior Settlement; or who otherwise may be identified through further reasonable effort;

- (b) contemporaneously with the mailing of the Notice Packet, the Claims Administrator shall cause copies of the Notice and the Claim Form to be posted on a website to be developed for the Settlement, from which copies of the Notice and Claim Form can be downloaded;
- (c) not later than ten (10) business days after the Notice Date, the Claims Administrator shall cause the Summary Notice, substantially in the form attached hereto as Exhibit 3, to be published once in the *Investor's Business Daily* and to be transmitted once over the PR Newswire; and
- (d) not later than seven (7) calendar days prior to the Settlement Fairness Hearing, Lead Counsel shall serve on Defendants' Counsel and file with the Court proof, by affidavit or declaration, of such mailing and publication.
- 8. Approval of Form and Content of Notice The Court (a) approves, as to form and content, the Notice, the Claim Form, and the Summary Notice, attached hereto as Exhibits 1, 2, and 3, respectively, and (b) finds that the mailing and distribution of the Notice and Claim Form and the publication of the Summary Notice in the manner and form set forth in paragraph 7 of this Order (i) is the best notice practicable under the circumstances; (ii) constitutes notice that is reasonably calculated, under the circumstances, to apprise HRG Subclass Members of the pendency of the Action, of the effect of the proposed Settlement (including the Releases to be provided thereunder), of Lead Counsel's motion for an award of attorneys' fees and Litigation Expenses, of their right to object to the Settlement, the Plan of Allocation, and Lead Counsel's

motion for attorneys' fees and Litigation Expenses, of their right to exclude themselves from the HRG Subclass, and of their right to appear at the Settlement Fairness Hearing; (iii) constitutes due, adequate, and sufficient notice to all persons and entities entitled to receive notice of the proposed Settlement; and (iv) satisfies the requirements of Rule 23 of the Federal Rules of Civil Procedure, the United States Constitution (including the Due Process Clause), the Private Securities Litigation Reform Act of 1995, 15 U.S.C. § 78u-4, as amended, and all other applicable law and rules. The date and time of the Settlement Fairness Hearing shall be included in the Notice and Summary Noticebefore they are mailed and published, respectively.

9. Nominee Procedures – Brokers and other nominees who purchased common stock of HRG from January 26, 2017 to July 13, 2018 for the benefit of another person or entity shall: (a) within seven (7) calendar days of receipt of the Notice, request from the Claims Administrator sufficient copies of the Notice Packet to forward to all such beneficial owners, and within seven (7) calendar days of receipt of those Notice Packets forward them to all such beneficial owners; or (b) within seven (7) calendar days of receipt of the Notice, send a list of the names, mailing addresses, and, if available, email addresses, of all such beneficial owners to the Claims Administrator in which event the Claims Administrator shall promptly mail or email the Notice Packet to such beneficial owners. However, brokers and nominees who previously provided names and addresses of potential settlement class members in connection with the Prior Settlement will not be required to provide those names and addresses again, but are required to provide the Claims Administrator only with names and addresses that were not previously provided, or any name or address changes. Upon full compliance with this Order, such nominees may seek payment of their reasonable expenses actually incurred in complying with this Order by providing the Claims Administrator with proper documentation supporting the expenses for which reimbursement is

sought. Such properly documented expenses incurred by nominees in compliance with the terms of this Order shall be paid from the Settlement Fund, with any disputes as to the reasonableness or documentation of expenses incurred subject to review by the Court.

- 10. **CAFA Notice** As provided in the Stipulation, Defendants shall serve the notice required under the Class Action Fairness Act, 28 U.S.C. § 1715, *et seq.* ("CAFA") no later than ten (10) calendar days following the filing of the Stipulation with the Court. Defendants are solely responsible for the costsof the CAFA notice and administering the CAFA notice. No later than seven (7) calendar days before the Settlement Fairness Hearing, Defendants shall cause to be served on Lead Counsel and filed with the Court proof, by affidavit or declaration, regarding compliance with the notice requirements of CAFA.
- 11. Participation in the Settlement HRG Subclass Members who wish to participate in the Settlement and to be eligible to receive a distribution from the Net Settlement Fund must complete and submit a Claim Form in accordance with the instructions contained therein. Unless the Court orders otherwise, all Claim Forms must be postmarked no later than one hundred twenty (120) calendar days after the Notice Date. However, any HRG Subclass Members who previously submitted a claim form in connection with the Prior Settlement will not be required to submit a new Claim Form. The information those Claimants previously submitted with respect to their transactions in HRG common stock will be used to calculate their claims for this Settlement. Notwithstanding the foregoing, Lead Counsel may, at its discretion, accept for processing late Claims provided such acceptance does not delay the distribution of the Net Settlement Fund to the HRG Subclass. By submitting a Claim, a person or entity shall be deemed to have submitted to the jurisdiction of the Court with respect to his, her, or its Claim and the subject matter of the Settlement.

- 12. Each Claim Form submitted must satisfy the following conditions: (a) it must be properly completed, signed, and submitted in a timely manner in accordance with the provisions of the preceding paragraph; (b) it must be accompanied by adequate supporting documentation for the transactions and holdings reported therein, in the form of broker confirmation slips, broker account statements, an authorized statement from the broker containing the transactional and holding information found in a broker confirmation slip or account statement, or such other documentation as is deemed adequate by Lead Counsel or the Claims Administrator; (c) if the person executing the Claim Form is acting in a representative capacity, a certification of his, her, or its current authority to act on behalf of the HRG Subclass Member must be included in the Claim Form to the satisfaction of Lead Counsel or the Claims Administrator; and (d) the Claim Form must be complete and contain no material deletions or modifications of any of the printed matter contained therein and must be signed under penalty of perjury.
- 13. Any HRG Subclass Member that does not timely and validly submit a Claim Form or whose Claim is not otherwise approved by the Court: (a) shall be deemed to have waived his, her, or its right to share in the Net Settlement Fund; (b) shall be forever barred from participating in any distributions therefrom; (c) shall be bound by the provisions of the Stipulation and the Settlement and all proceedings, determinations, orders, and judgments in the Action relating thereto, including, without limitation, the Judgment and the Releases provided for therein, whether favorable or unfavorable to the HRG Subclass; and (d) will be barred from commencing, maintaining, or prosecuting any of the Released Plaintiffs' Claims against each and all of the Defendants' Releasees, as more fully described in the Stipulation and Notice. Notwithstanding the foregoing, late Claim Forms may be accepted for processing as set forth in paragraph 11 above.
- 14. **Exclusion From the HRG Subclass** Any member of the HRG Subclass who wishes to

exclude himself, herself, or itself from the HRG Subclass must request exclusion in writing within the time and in the manner set forth in the Notice, which shall provide that: (a) any such request for exclusion from the HRG Subclass must be mailed or delivered such that it is received no later than twenty-one (21) calendar days prior to the Settlement Fairness Hearing, to: HRG Securities Litigation, EXCLUSIONS, c/o JND Legal Administration, P.O. Box 91427, Seattle, WA 98111 and (b) each request for exclusion must (i) state the name, address, and telephone number of the person entity requesting exclusion, and in the case of entities, the name and telephone number of the appropriate contact person; (ii) state that such person or entity "requests exclusion from the HRG Subclass in Jet Capital Master Fund, L.P. v. HRG Group, Inc., Case No. 21-cv-552-jdp"; (iii) state (A) the number of shares of HRG common stock that the person or entity requesting exclusion owned as of the opening of trading on January 26, 2017; and (B) the number of shares of HRG common stock that the person orentity requesting exclusion purchased and sold during the period from January 26, 2017 to July 13, 2018, including the dates, number of shares, and prices of each such purchase and sale; and (iv) be signed by the person or entity requesting exclusion or an authorized representative. A request for exclusion shall not be effective unless it provides all the required information and is received within the time stated above, or is otherwise accepted by the Court. Lead Counsel is authorized to request from any person or entity requesting exclusion additional transaction information or documentation sufficient to prove his, her, or its holdings and trading in HRG common stock.

15. Any person or entity who or which timely and validly requests exclusion in compliance with the terms stated in this Order and is excluded from the HRG Subclass shall not be an HRG Subclass Member, shall not be bound by the terms of the Settlement or any orders or judgments in the Action related to the Settlement, and shall not receive any payment out of the Net Settlement

Fund.

- 16. Any HRG Subclass Member who or which does not timely and validly request exclusion from the HRG Subclass in the manner stated in this Order: (a) shall be deemed to have waived his, her, or its right to be excluded from the HRG Subclass; (b) shall be forever barred from requesting exclusion from the HRG Subclass in this or any other proceeding; (c) shall be bound by the provisions of the Stipulation and Settlement and all proceedings, determinations, orders, and judgments in the Action, including, but not limited to, the Judgment and the Releases provided for therein, whether favorable or unfavorable to the HRG Subclass; and (d) will be barred from commencing, maintaining, or prosecuting any of the Released Plaintiffs' Claims against any of the Defendants' Releasees, as more fully described in the Stipulation and Notice.
- Appearance and Objections at Settlement Fairness Hearing Any HRG Subclass Member who or which does not request exclusion from the HRG Subclass may enter an appearance in the Action, at his, her, or its own expense, individually or through counsel of his, her, or its own choice, by filing with the Clerk of Court and delivering a notice of appearance to both Lead Counsel and Defendants' Counsel, at the addresses set forth in paragraph 18 below, such that it is received no later than twenty-one (21) calendar days prior to the Settlement Fairness Hearing, or as the Court may otherwise direct. Any HRG Subclass Member who does not enter an appearance will be represented by Lead Counsel.
- 18. Any HRG Subclass Member who or which does not request exclusion from the HRG Subclass may file a written objection to the proposed Settlement, the proposed Plan of Allocation, and/or Lead Counsel's motion for attorneys' fees and Litigation Expenses and appear and show cause, if he, she, or it has any cause, why the proposed Settlement, the proposed Plan of Allocation, and/or Lead Counsel's motion for attorneys' fees and Litigation Expenses should not be approved;

provided, however, that no HRG Subclass Member shall be heard or entitled to contest the approval of the terms and conditions of the proposed Settlement, the proposed Plan of Allocation, and/or the motion for attorneys' fees and Litigation Expenses unless that person or entity has filed a written objection with the Court and served copies of such objection on Lead Counsel and Defendants' Counsel at the addresses set forth below such that they are received no later than twenty-one (21) calendar days prior to the Settlement Fairness Hearing.

HRG Group, Inc.*, Case No. 21-cv-552-jdp; (b) state the name, address, and telephone number of the person or entity objecting and must be signed by the objector; (c) state with specificity the grounds for the HRG Subclass Member's objection, including any legal and evidentiary support the HRG Subclass Member wishes to bring to the Court's attention and whether the objection applies only to the objector, to a specific subset of the HRG Subclass, or to the entire HRG Subclass; and (d) include documents sufficient to prove membership in the HRG Subclass, including documents showing (i) the number of shares of HRG common stock that the objecting HRG Subclass Member owned as of the opening of trading on January 26, 2017; and (ii) the number of shares of HRG common stock that the objecting HRG Subclass Member purchased and sold during the period from

January 26, 2017 to July 13, 2018, including the dates, number of shares, and prices of each such purchase and sale. Documentation establishing membership in the HRG Subclass must consist of copies of brokerage confirmation slips or monthly brokerage account statements, or an authorized statement from the objector's broker containing the transactional and holding information found in a broker confirmation slip or account statement. Objectors who enter an appearance and desire to present evidence at the Settlement Fairness Hearing in support of their objection must include in their written objection or notice of appearance the identity of any witnesses they may call to testify and any exhibits they intend to introduce into evidence at the hearing. It is within the Court's discretion to allow appearances at the Settlement Fairness Hearing either in person or by telephone or video conference.

- 20. Any HRG Subclass Member who or which does not make his, her, or its objection in the manner provided herein shall be deemed to have waived his, her, or its right to object to any aspect of the proposed Settlement, the proposed Plan of Allocation, and Lead Counsel's motion for an award of attorneys' fees and Litigation Expenses and shall be forever barred and foreclosed from objecting to the fairness, reasonableness, or adequacy of the Settlement, the Plan of Allocation, or the requested attorneys' fees and Litigation Expenses, or from otherwise being heard concerning the Settlement, the Plan of Allocation, or the requested attorneys' fees and Litigation Expenses in this or any other proceeding.
- 21. <u>Stav and Temporary Injunction</u> Until otherwise ordered by the Court, the Court stays all proceedings in the Action other than proceedings necessary to carry out or enforce the terms and conditions of the Stipulation. Pending final determination of whether the Settlement should be approved, the Court bars and enjoins Lead Plaintiff and all other members of the HRG Subclass from prosecuting any or all of the Released Plaintiffs' Claims against any of the Defendants'

Releasees.

- 22. <u>Settlement Administration Fees and Expenses</u> All costs incurred in identifying HRG Subclass Members and notifying them of the Settlement as well as in administering the Settlement shall be paid as set forth in the Stipulation without further order of the Court.
- 23. <u>Settlement Fund</u> The contents of the Settlement Fund held by Peapack-Gladstone Bank (which the Court approves as the Escrow Agent) shall be deemed and considered to be *in custodia legis* of the Court, and shall remain subject to the jurisdiction of the Court, until such time as they shall be distributed pursuant to the Stipulation and/or further order(s) of the Court.
- 24. <u>Taxes</u> Lead Counsel is authorized and directed to prepare any tax returns and any other tax reporting form for or in respect to the Settlement Fund, to pay from the Settlement Fund any Taxes owed with respect to the Settlement Fund, and to otherwise perform all obligations with respect to Taxes and any reporting or filings in respect thereof without further order of the Court in a manner consistent with the provisions of the Stipulation.
- 25. **Termination of Settlement** If the Settlement is terminated as provided in the Stipulation, the Settlement is not approved, or the Effective Date of the Settlement otherwise fails to occur, this Order shall be vacated and rendered null and void, and shall be of no further force and effect, except as otherwise provided by the Stipulation, and this Order shall be without prejudice to the rights of Lead Plaintiff, the other HRG Subclass Members, and Defendants, and Lead Plaintiff and Defendants shall revert to their respective positions in the Action as of immediately prior to the execution of the Term Sheet on September 20, 2021, as provided in the Stipulation.
- 26. <u>Use of this Order</u> Neither this Order, the Term Sheet, the Stipulation (whether or not consummated), including the exhibits thereto and the Plan of Allocation contained therein (or any other plan of allocation that may be approved by the Court), the negotiations leading to the

execution of the Term Sheet and the Stipulation, nor any proceedings taken pursuant to or in connection with the Term Sheet, the Stipulation, and/or approval of the Settlement (including any arguments proffered in connection therewith): (a) shall be offered against any of the Defendants' Releasees as evidence of, or construed as, or deemed to be evidence of any presumption, concession, or admission by any of the Defendants' Releasees with respect to the truth of any fact alleged by Lead Plaintiffs or the validity of any claim that was or could have been asserted or the deficiency of any defense that has been or could have been asserted in this Action or in any other litigation, or of any liability, negligence, fault, or other wrongdoing of any kind of any of the Defendants' Releasees or in any way referred to for any other reason as against any of the Defendants' Releasees, in any arbitration proceeding or other civil, criminal, or administrative actionor proceeding, other than such proceedings as may be necessary to effectuate the provisions of the Stipulation; (b) shall be offered against any of the Plaintiffs' Releasees, as evidence of, or construed as, or deemed to be evidence of any presumption, concession, or admission by any of the Plaintiffs' Releasees that any of their claims are without merit, that any of the Defendants' Releasees had meritorious defenses,or that damages recoverable under the Complaint would not have exceeded the Settlement Amount or with respect to any liability, negligence, fault, or wrongdoing of any kind, or in any way referred to for any other reason as against any of the Plaintiffs' Releasees, in any arbitration proceeding or other civil, criminal, or administrative action or proceeding, other than such proceedings as may be necessary to effectuate the provisions of the Stipulation; or (c) shall be construed against any of the Releasees as an admission, concession, or presumption that the consideration to be given hereunder represents the amountwhich could be or would have been recovered after trial; provided, however, that if the Stipulation is approved by the Court, the Parties and the Releasees and their respective counsel may refer to it to effectuate the

protections from liability granted hereunder or otherwise to enforce the terms of the Settlement.

27. <u>Supporting Papers</u> – Lead Counsel shall file and serve the opening papers in support of

the proposed Settlement, the proposed Plan of Allocation, and Lead Counsel's motion for an award

of attorneys' fees and payment of Litigation Expenses no later than thirty-five (35) calendar days

prior to the Settlement Fairness Hearing; and reply papers, if any, shall be filed and served no later

than seven (7) calendar days prior to the Settlement Fairness Hearing.

28. <u>Jurisdiction</u> – The Court retains jurisdiction to consider all further applications arising out

of or connected with the proposed Settlement.

NOTICE OF PENDENCY OF CLASS ACTION: Please be advised that your rights may be affected by the above-captioned securities class action (the "Action") pending in the United States District Court for the Western District of Wisconsin (the "Court"), if during the period from January 26, 2017 to July 13, 2018, you purchased HRG Group, Inc. ("HRG") common stock (NYSE: HRG; CUSIP: 40434J100) and were damaged thereby.¹

NOTICE OF SETTLEMENT: Please also be advised that the Court-appointed Lead Plaintiff, Jet Capital Master Fund, L.P. ("Lead Plaintiff"), on behalf of itself and the HRG Subclass (as defined in ¶ 30 below), has reached a proposed settlement of the claims asserted by the HRGSubclass in the Action for \$7,250,000 in cash.

PLEASE NOTE: You may have received notice of a previous proposed settlement of this Action in late 2020. That earlier proposed settlement was not approved by the Court. The prior settlement has been withdrawn and is no longer before the Court. That previously proposed settlement included claims arising from purchases of Spectrum Brands Legacy, Inc. ("Old Spectrum") common stock and Spectrum Brands Holdings, Inc. ("Spectrum") common stock. As further described in this Notice, this Settlement relates *only* to claims arising from the purchases of HRG common stock. The claims arising from purchases of Old Spectrum and Spectrum common stock will not be settled or released by this Settlement.

PLEASE READ THIS NOTICE CAREFULLY. This Notice explains important rights you may have, including the possible receipt of a payment from the Settlement. If you are a member of the HRG Subclass, your legal rights will be affected whether or not you act.

If you have any questions about this Notice, the proposed Settlement, or your eligibility to participate in the Settlement, please DO NOT contact the Court, the Office of the Clerk of the Court, Defendants, or their counsel. All questions should be directed to Lead Counsel or the Claims Administrator ($see \ 96 \ below$).

- 1. **Description of the Action and the HRG Subclass:** This Notice relates to a proposed Settlement of claims in a pending securities class action brought by investors alleging, among other things, that defendants Spectrum, Old Spectrum, HRG, Andreas R. Rouvé, David M. Maura, and Douglas L. Martin (collectively, "Defendants") violated the federal securities laws by making false and misleading statements regarding the consolidation of Spectrum's distribution network. A more detailed description of the Action is set forth in ¶¶ 11-29 below. The proposed Settlement, if approved by the Court, will settle claims of the HRG Subclass, as defined in ¶ 30 below.
- 2. **Statement of the HRG Subclass's Recovery:** Subject to Court approval, Lead Plaintiff, on behalf of itself and the HRG Subclass, have agreed to settle the claims ofthe HRG Subclass in the Action in exchange for \$7,250,000 in cash (the "Settlement Amount") to be deposited into an escrow account. The Net Settlement Fund (*i.e.*, the Settlement Amount plus any and all interest earned thereon (the "Settlement Fund") less (i) any Taxes; (ii) any Notice and Administration Costs; (iii) any Litigation Expenses awarded by the Court; (iv) any attorneys' fees awarded by the Court; and (v) any other costs or fees approved by the Court) will be distributed in accordance with a plan of allocation that is approved by the Court. The proposed plan of allocation (the "Plan of Allocation" or "Plan") is set forth in ¶¶ 59-77 below. The Plan of Allocation will determine how the Net Settlement Fund will be allocated among members of the HRG Subclass.
- 3. Estimate of Average Amount of Recovery Per Share: Based on Lead Plaintiff's damages expert's estimate of the number of shares of HRG common stock purchased during the period from January 26, 2017 to July 13, 2018 (the "Class Period") that may have been affected by the conduct at issue in the Action, and assuming that all HRG Subclass Members elect to participate in the Settlement, the estimated average recovery (before the deduction of any Courtapproved fees, expenses, and costs as described herein) is \$0.50 per affected share of HRG common stock. HRG Subclass Members should note, however, that the foregoing average recovery per share is only an estimate. HRG Subclass Members may recover more or less than these estimated amounts depending on, among other factors, when and at what prices they purchased or sold their HRG common stock, and the total number andvalue of valid Claim Forms submitted. Distributions to HRG Subclass Members will be made based on the Plan of Allocation set forth herein (see ¶¶ 59-77 below) or such other plan of allocation as may be ordered by the Court.
- 4. **Average Amount of Damages Per Share:** The Parties do not agree on the average amount of damages per share that would be recoverable if Lead Plaintiff were to prevail in the Action. Among other things, Defendants expressly deny that they violated the federal securities laws or that any damages were suffered by any members of the HRG Subclass as a result of their conduct.
- 5. Attorneys' Fees and Expenses Sought: Lead Counsel, who have been prosecuting the Action on a wholly contingent basis, have not received any payment of attorneys' fees for their representation of the HRG Subclass and have advanced the funds to pay expenses necessarily incurred to prosecute the Action. Court-appointed Lead Counsel, Rolnick Kramer Sadighi LLP, will apply to the Court for an award of attorneys' fees in an amount not to exceed 22% of the Settlement Fund. In addition, Lead Counsel will apply for payment of Litigation Expenses

incurred in connection with the institution, prosecution, and resolution of the Action in an amount not to exceed \$500,000, which may include an application for reimbursement of the reasonable costs and expenses incurred by Lead Plaintiff directly related to its representation of the HRG Subclass, pursuant to the Private Securities Litigation Reform Act of 1995 ("PSLRA"). Any fees and expenses awarded by the Court will be paid from the Settlement Fund. HRG Subclass Members are not personally liable for any such fees or expenses. The estimated average cost for such fees and expenses, if the Court approves Lead Counsel's fee and expense application, is \$0.14 per share of HRG common stock.

- 7. **Reasons for the Settlement:** Lead Plaintiff's principal reason for entering into the Settlement is the substantial and certain recovery for the HRG Subclass without the risk or thedelays inherent in further litigation. Moreover, the substantial recovery provided under the Settlement must be considered against the significant risk that a smaller recovery—or indeed no recovery at all—might be achieved after contested motions, a trial of the Action, and the likely appeals that would follow a trial. This process could be expected to last several years. Defendants, who deny that they have committed any act or omission giving rise to liability under the federal securities laws, are entering into the Settlement solely to eliminate the uncertainty, burden, and expense of further protracted litigation.

WHY DID I GET THIS NOTICE?

- 8. The Court directed that this Notice be mailed to you because you or someone in your family or an investment account for which you serve as a custodian may have purchased HRG common stock during the Class Period. The Court has directed us to send you this Notice because, as a potential HRG Subclass Member, you have a right to know about your options before the Court rules on the proposed Settlement. Additionally, you have the right to understand how this class action lawsuit may generally affect your legal rights. If the Court approves the Settlement and the Plan of Allocation (or some other plan of allocation), the Claims Administrator selected by Lead Plaintiff and approved by the Court will make payments pursuant to the Settlement after any objections and appeals are resolved.
- 9. The purpose of this Notice is to inform you of the existence of this case, that it is a class action, and how you might be affected, and how to exclude yourself from the HRG Subclass if you wish to do so. It is also being sent to inform you of the terms of the proposed Settlement and of a hearing to be held by the Court to consider the fairness, reasonableness, and adequacy of the Settlement, the proposed Plan of Allocation, and the motion by Lead Counsel for an award of attorneys' fees and payment of Litigation Expenses (the "Settlement Fairness Hearing"). See \$\frac{1}{2}\$ 85-86 below for details about the Settlement Fairness Hearing, including the date and location of the hearing.
- 10. The issuance of this Notice is not an expression of any opinion by the Court concerning the merits of any claim in the Action, and the Court still has to decide whether to approve the

Settlement. If the Court approves the Settlement and a plan of allocation, then payments to Authorized Claimants will be made after any appeals are resolved and after the completion of all claims processing. Please be patient, as this process can take some time to complete.

WHAT IS THIS CASE ABOUT?

- 11. Spectrum is a consumer-goods company that provides products to consumers through retail partners such as Wal-Mart, Home Depot, and Lowe's. HRG was Spectrum's majority shareholder. In this Action, Lead Plaintiff alleges that the Company and the Individual Defendants made a series of materially misleading statements and omissions regarding the Company's operations and financial results during the Class Period. Lead Plaintiff further alleges that the HRG Subclass suffered damages when the alleged truth regarding these matters was publicly disclosed.
- 12. Beginning on March 7, 2019, certain related class actions (*Earl S. Wagner v. Spectrum Brands Legacy, Inc.*, et al., No. 19-cv-178-jdp, and *West Palm Beach Firefighters' Pension Fund v. Spectrum Brands Legacy, Inc.*, et al., No. 19-cv-347-jdp) were filed in the United States District Court for the Western District of Wisconsin (the "Court") alleging violations of the federal securities laws.
- 13. By Order dated June 12, 2019, the Court: (i) consolidated the related actions in the action captioned *In re Spectrum Brands Securities Litigation*, No. 19-cv-347-jdp (W.D. Wis.) (the "Spectrum Action"); (ii) appointed the Public School Teachers' Pension and Retirement Fund of Chicago and the Cambridge Retirement System to serve as lead plaintiffs (the "Spectrum Subclass Lead Plaintiffs"); and (iii) approved the Spectrum Subclass Lead Plaintiffs' choice of Bernstein Litowitz Berger & Grossmann LLP as lead counsel and Rathje Woodward LLC as liaison counsel.
- 14. On July 12, 2019, the Spectrum Subclass Lead Plaintiffs filed the Amended Class Action Complaint for Violations of the Federal Securities Laws (the "Amended Complaint" or "Complaint") asserting claims against Defendants Spectrum, Old Spectrum, and the Individual Defendants under Section 10(b) of the Securities Exchange Act of 1934 (the "Exchange Act") and Rule 10b-5 promulgated thereunder, and against the Individual Defendants and Defendant HRG under Section 20(a) of the Exchange Act. Among other things, the Amended Complaint alleges that Defendants falsely stated that Spectrum was successfully executing two major supply-chain consolidation projects in its Global Auto Care ("GAC") and Hardware and Home Improvement ("HHI") divisions, when in fact the GAC and HHI consolidations were suffering from fundamental logistical, operational, andtechnical problems that were far more serious than those disclosed to investors. The Amended Complaint further alleges that the prices of Spectrum's, Old Spectrum's, and HRG's common stock were artificially inflated during the *Spectrum* Action Class Period as a result of Defendants' allegedly false and misleading statements, and declined when the truth was revealed.
- 15. On August 26, 2019, Defendants filed their motion to dismiss the Amended Complaint (the "Motion to Dismiss"). On October 10, 2019, the Spectrum Subclass Lead Plaintiffs filed their memorandum of law in opposition to Defendants' Motion to Dismiss and, on November 6, 2019, Defendants filed their reply papers in further support of the Motion to Dismiss.
- 16. On January 7, 2020, the Spectrum Subclass Lead Plaintiffs and Defendants filed a letter notifying the Court that they had agreed to a mediation of the *Spectrum* Action before a private mediator and jointly requested that the Court defer decision on the fully briefed motion to dismiss

pending the outcome of the mediation. That same day, the Court entered an order denying without prejudice the Motionto Dismiss.

- 17. On August 10, 2020, Parties entered into a Stipulation and Agreement of Settlement providing for the settlement of all claims in the *Spectrum* Action for \$39,000,000 in cash (the "Prior Settlement"). The Prior Settlement was on behalf of a settlement class consisting of persons and entities who purchased Spectrum, Old Spectrum, or HRG common stock during the period from January 26, 2017 to November 19, 2018, inclusive, and were damaged thereby.
- 18. On January 8, 2021, Jet Capital (along with Jet Capital SRM Master Fund, L.P. and Walleye Investments Fund, also represented by Lead Counsel) objected to the Prior Settlement and sought to intervene in the *Spectrum* Action, arguing that (i) the Spectrum Subclass Lead Plaintiffs were not adequate representatives for purchasers of HRG common stock, under the PSLRA and otherwise; and (ii) the plan of allocation in the Prior Settlement was unreasonable as to purchasers of HRG common stock.
- 19. On February 6, 2021, the Court entered an Order denying without prejudice the Spectrum Subclass Lead Plaintiffs' motion for final approval of the Prior Settlement and the intervention motion.
- 20. Pursuant to the Court's February 6, 2021 Order, on February 19, 2021, the Spectrum Subclass Lead Plaintiffs submitted a proposed plan to the Court to divide the putative class into separate subclasses of Spectrum investors (the "Spectrum Subclass") and HRG investors (the "HRG Subclass"), and to provide a Private Securities Litigation Reform Act ("PSLRA") notice for an additional lead plaintiff to represent the HRG Subclass.
- 21. Upon approval by the Court, on April 2, 2021, the Spectrum Subclass Lead Plaintiffs issued the PSLRA notice topurchasers of HRG common stock during the asserted Class Period via PRNewswire.
- 22. On May 26, 2021, Jet Capital moved to be appointed lead plaintiff for the HRG Subclass.
- 23. On June 10, 2021, the Court granted Jet Capital's unopposed motion to serve as lead plaintiff for the HRG Subclass.
- 24. The Spectrum Subclass Lead Plaintiffs, Defendants, and Jet Capital engaged in mediation before Jed Melnick, Esq.in an effort to reach a settlement on behalf of both the Spectrum Subclass and the HRG Subclass, which included a formal mediation session on July 22, 2021.
- 25. The Spectrum Subclass Lead Plaintiffs, Defendants, and Jet Capital were unsuccessful in negotiating a mutually acceptable allocation of the \$39,000,000 in settlement consideration that had previously been agreed for both subclasses.
- 26. On August 27, 2021, the Court ordered the claims of the HRG Subclass severed from the *Spectrum* Action, and pursuant to the Court's August 27, 2021 Order, this Action was created, captioned *Jet Capital Master Fund, L.P. v. HRG Group, Inc.*, No. 21-cv-552-jdp.
- 27. Jet Capital and Defendants then reached an agreement in principle to settle the Actionwith respect to the HRG Subclass, which was memorialized in a term sheet executed on September 20, 2021 (the "Term Sheet"). The Term Sheet set forth, among other things, the Parties' agreement to settle and release all claims of the HRG Subclass against Defendants in the Action in return for a cash payment of \$7,250,000 for the benefit of the HRG Subclass, subject to certain terms and

conditions and the execution of a customary "long form" stipulation and agreement of settlement and related papers.

- 28. On October 8, 2021, the Parties entered into the Stipulation and Agreement of Settlement, which sets forth the terms and conditions of the Settlement. The Stipulation is available at www.HRGSecuritiesLitigation.com.
- 29. On______, 2021, the Court preliminarily approved the Settlement, authorized thisNotice to be disseminated to potential HRG Subclass Members, and scheduled the SettlementFairness Hearing to consider whether to grant final approval of the Settlement.

HOW DO I KNOW IF I AM AFFECTED BY THE SETTLEMENT? WHO IS INCLUDED IN THE HRG SUBCLASS?

30. If you are a member of the HRG Subclass, you are subject to the Settlement unless you timely request to be excluded. The HRG Subclass consists of:

all persons and entities that purchased common stock of HRG from January 26, 2017 to July 13, 2018 (the "Class Period") and were damaged thereby (the "HRG Subclass").

Excluded from the HRG Subclass are: (i) Defendants (including Spectrum); (ii) the Immediate Family members of the Individual Defendants; (iii) the Officers and directors of Old Spectrum, Spectrum, and HRG currently and from January 26, 2017 to November 19, 2018, and their Immediate Family members; (iv) any entity in which any of the foregoing excluded persons or entities has or had a controlling interest; and (v) the legal representatives, heirs, successors, or assigns of any such excluded person or entity. This Settlement does not settle or release claims arising out of purchases of (i) common stock of Old Spectrum from January 26, 2017 to July 13, 2018; and/or (ii) common stock of Spectrum from July 13, 2018 to November 19, 2018. Also excluded from the HRG Subclass are any persons and entities who or which previously submitted a request for exclusion from the settlement class in connection with the Prior Settlement,² or exclude themselves by submitting a request for exclusion in accordance with the requirements set forth in this Notice. *See* "What If I Do Not Want To Be A Member Of The HRG Subclass? How Do I Exclude Myself?" on page 18 below.

PLEASE NOTE: RECEIPT OF THIS NOTICE DOES NOT MEAN THAT YOU ARE A HRG SUBCLASS MEMBER OR THAT YOU WILL BE ENTITLED TO A PAYMENT FROM THE SETTLEMENT. IF YOU ARE A SPECTRUM SUBCLASS MEMBER AND YOU WISH TO BE ELIGIBLE TO RECEIVE A PAYMENT FROM THESETTLEMENT, YOU ARE REQUIRED TO SUBMIT THE CLAIM FORM THAT IS BEING DISTRIBUTED WITH THIS NOTICE AND THE REQUIRED SUPPORTING DOCUMENTATION AS SET FORTH THEREIN POSTMARKED NO LATER THAN ________, 2021.

WHAT ARE LEAD PLAINTIFFS' REASONS FOR THE SETTLEMENT?

31. Lead Plaintiff and Lead Counsel believe that the claims asserted against Defendants have merit. They recognize, however, the expense and length of continued proceedings necessary to

pursue their claims against Defendants through a motion to dismiss, summary judgment, trial, and appeals, as well as the very substantial risks Lead Plaintiff would face in establishing liability and damages. For example, Defendants would have argued in a motion to dismiss that the HRG Subclass could not bring their securities claims because they did not purchase Old Spectrum or Spectrum stock. In addition, Lead Plaintiff would have faced substantial challenges in proving that certain of Spectrum's statements about the GAC and HHI consolidations were actionable under the federal securities laws. Specifically, Defendants had credible arguments that their statements about the progress of both initiatives, including the "transitory" nature of the consolidation issues affecting the Company, were not false. Defendants would have continued to argue that the consolidations were progressing adequately during much of the Class Period, and that the issues facing the consolidations were in fact transitory, because the issues were significantly resolved by the end of the Class Period. In addition, Lead Plaintiff would have faced challenges in proving that Defendants made the alleged false statements with the intent to mislead investors or were reckless in making the statements. For example, Defendants would have continued to argue that the Company was making adequate progress in consolidating its distribution networks, and that Defendants were only made aware of any deeper issues later in the Class Period—directly before Defendants informed the market of these issues.

- 32. Lead Plaintiff would also have faced significant hurdles in proving "loss causation"—that the alleged misstatements were the cause of investors' losses—and in proving damages with respect to the alleged corrective disclosures. For example, Defendants have argued and would continue to argue that a substantial portion, if not all, of the negative news released to the market that Lead Plaintiff alleged disclosed the fraud actually was totally unrelated to the alleged fraud.If Defendants were successful, Lead Plaintiff's maximum damages would be substantially reducedor eliminated entirely.
- 33. In light of these risks, the amount of the Settlement, and the immediacy of recovery to the HRG Subclass, Lead Plaintiff and Lead Counsel believe that the proposed Settlement is fair, reasonable, and adequate, and in the best interests of the HRG Subclass. Lead Plaintiff and Lead Counsel believe that the Settlement provides a substantial benefit to the HRG Subclass,namely \$7,250,000 in cash (less the various deductions described in this Notice), as compared tothe risk that the claims in the Action would produce a smaller recovery, or no recovery, after the Court's decision on a motion to dismiss, summary judgment, trial, and appeals, possibly years in the future.
- 34. Defendants have expressly denied the claims asserted against them in the Action and expressly deny that the HRG Subclass was harmed or suffered any damages as a result of the conduct alleged in the Action. Defendants have agreed to the Settlement solely to eliminate the burden and expense of continued litigation. Accordingly, the Settlement may not be construed as an admission by Defendants of any fault, liability, wrongdoing, or damages.

WHAT MIGHT HAPPEN IF THERE WERE NO SETTLEMENT?

35. If there were no Settlement and Lead Plaintiffs failed to establish any essential legal or factual element of their claims against Defendants, neither Lead Plaintiff nor the other membersof the HRG Subclass would recover anything from Defendants. Also, if Defendants were successful in proving any of their defenses, either on a motion to dismiss, on summary judgment, at trial, or on appeal, the HRG Subclass could recover substantially less than the amount provided in the Settlement, or nothing at all.

HOW ARE HRG SUBCLASS MEMBERS AFFECTED BY THE ACTION AND THE SETTLEMENT?

- 36. As an HRG Subclass Member, you are represented by Lead Plaintiff and Lead Counsel, unless you enter an appearance through counsel of your own choice at your own expense. You are not required to retain your own counsel, but if you choose to do so, such counsel must file a notice of appearance on your behalf and must serve copies of his or her appearance on the attorneys listed in the section entitled "When And Where Will The Court Decide Whether To Approve The Settlement?" below.
- 37. If you are an HRG Subclass Member and do not wish to remain an HRG Subclass Member, you may exclude yourself from the HRG Subclass by following the instructions in the section entitled "What If I Do Not Want To Be A Member Of The HRG Subclass? How Do I Exclude Myself?" below.
- 38. If you are an HRG Subclass Member and you wish to object to the Settlement, the Planof Allocation, or Lead Counsel's application for attorneys' fees and Litigation Expenses, and if you do not exclude yourself from the HRG Subclass, you may present your objections by following the instructions in the section entitled "When And Where Will The Court Decide Whether To Approve The Settlement?" below.
- 39. If you are an HRG Subclass Member and you do not exclude yourself from the HRG Subclass, you will be bound by any orders issued by the Court. If the Settlement is approved, the Court will enter a judgment (the "Judgment"). The Judgment will dismiss with prejudice the HRG Subclass's claims against Defendants and will provide that, upon the Effective Date of the Settlement, Lead Plaintiff and each of the other HRG Subclass Members will have fully, finally, and forever compromised, settled, released, resolved, relinquished, waived, and dischargedall of the Released Plaintiffs' Claims (as defined in ¶ 40 below) against Defendants and the other Defendants' Releasees (as defined in ¶ 41 below), and will forever be barred and enjoined from prosecuting any of the Released Plaintiffs' Claims against any of the Defendants' Releasees.
- "Released Plaintiffs' Claims" means all claims, demands, losses, liabilities, rights, and causes of action of any nature whatsoever, whether known claims or Unknown Claims (as defined in ¶ 42 below), whether arising under federal, state, common, or foreign law, whether brought directly or indirectly, that (i) the Spectrum Subclass Lead Plaintiffs asserted on behalf of members of the HRG Subclass in the Complaint or (ii) that Lead Plaintiff or any other members of the HRG Subclass, on behalf of themselves and their respective successors, assigns, executors, administrators, representatives, attorneys, and agents, in their capacities as such, could have asserted in this Action or could in the future assert in any forum that arise out of, are based upon, or relate to in any way to (a) any of the allegations, acts, transactions, facts, events, matters, occurrences, representations or omissions involved, set forth, alleged, or referred to in the Complaint and (ii) the purchase, acquisition, sale, or holding HRG common stock during the Class Period by members of the HRG Subclass. The Released Plaintiffs' Claims do not include: (i) any claims relating to the enforcement of the Settlement; (ii) any claims arising out of purchases of Old Spectrum common stock from January 26, 2017 to July 13, 2018; (iii) any claims arising out of purchases of Spectrum common stock from July 13, 2018 to November 19, 2018; (iv) any claims asserted in Plymouth Cty. Ret. Ass'n v. Spectrum Brands Holdings, Inc., et al., 2019CV000982

- (Wis. Cir. Ct. Dane Cnty.); (v) any claims asserted in any derivative action or ERISA action; and (vi) any claims of any person or entity who or which previously submitted a request for exclusion from the settlement class in connection with Prior Settlement or submits a request for exclusion from the HRG Subclass that is accepted by the Court.
- 41. "Defendants' Releasees" means (i) Defendants; (ii) the present and former parents, subsidiaries, divisions, and affiliates of Spectrum, Old Spectrum, and HRG; (iii) the present and former attorneys, insurers, and agents of each of the foregoing in (i)-(iii); and (v) the predecessors, heirs, successors, and assigns of each of the foregoing in (i)-(iv).
- 42. "Unknown Claims" means any Released Plaintiffs' Claims which Lead Plaintiff or any other HRG Subclass Member does not know or suspect to exist in his, her, or its favor at the time of the release of such claims, and any Released Defendants' Claims which any Defendant does not know or suspect to exist in his, her, or its favor at the time of the release of such claims, which, if known by him, her, or it, might have affected his, her, or its decision(s) with respect to this Settlement. With respect to any and all Released Claims, the Parties stipulate and agree that, upon the Effective Date of the Settlement, Lead Plaintiff and Defendants shall expressly waive, and each of the other HRG Subclass Members shall be deemed to have waived, and by operation of the Judgment or the Alternate Judgment, if applicable, shall have expressly waived, any and all provisions, rights, and benefits conferred by any law of any state or territory of the United States, or principle of common law or foreign law, which is similar, comparable, or equivalent to California Civil Code § 1542, which provides:

A general release does not extend to claims that the creditor or releasing party does not know or suspect to exist in his or her favor at the time of executing the release and that, if known by him or her, would have materially affected his or her settlement with the debtor or released party.

Lead Plaintiff and Defendants acknowledge, and each of the other HRG Subclass Members shall be deemed by operation of law to have acknowledged, that the foregoing waiver was separately bargained for and a key element of the Settlement.

- 43. The Judgment will also provide that, upon the Effective Date of the Settlement, Defendants, on behalf of themselves, and their respective successors, assigns, executors, administrators, representatives, attorneys, and agents, in their capacities as such, will have, fully, finally, and forever compromised, settled, released, resolved, relinquished, waived, and discharged any or all of the Released Defendants' Claims (as defined in ¶ 44 below) against Lead Plaintiffs and the other Plaintiffs' Releasees (as defined in ¶ 45 below), and will forever be barred and enjoined from prosecuting any or all of the Released Defendants' Claims against any of the Plaintiffs' Releasees.
- 44. "Released Defendants' Claims" means all claims, demands, losses, liabilities, rights, and causes of action of any nature whatsoever, whether known claims or Unknown Claims, whether arising under federal, state, common, or foreign law, whether brought directly or indirectly, that arise out of or relate in any way to the institution, prosecution, or settlement of the claims asserted in the Action against Defendants. Released Defendants' Claims do not include: (i) any claims relating to the enforcement of the Settlement, and (ii) any claims against any person or entity who or which previously submitted a request for exclusion from the settlement class in connection with the Prior Settlement or submits a request for exclusion from the HRG Subclass that is acceptedby

the Court.

45. "Plaintiffs' Releasees" means (i) Lead Plaintiff, all other HRG Subclass Members, and Plaintiffs' Counsel; (ii) the present and former parents, subsidiaries, divisions, and affiliates of each of the foregoing in (i); (iii) the present and former employees, Officers, directors, and trustees of each of the foregoing in (i)-(ii); (iv) the present and former attorneys, insurers, and agents of each of the foregoing in (i)-(iii); and (v) the predecessors, heirs, successors, and assigns of each of the foregoing in (i)-(iv).

HOW DO I PARTICIPATE IN THE SETTLEMENT? WHAT DO I NEED TO DO?

- 47. A Claim Form is included with this Notice, or you may obtain one from the website maintained by the Claims Administrator for the Settlement, www.HRGSecuritiesLitigation.com. You may also request that a Claim Form be mailed to you by calling the Claims Administrator toll free at 1-888-921-1535 or by emailing the Claims Administrator at info@HRGSecuritiesLitigation.com. Please retain all records of your ownership of and transactions in HRG common stock, as they will be needed to document your Claim. The Parties and Claims Administrator do not have information about your transactions in HRG common stock.
- 48. If you request exclusion from the HRG Subclass or do not submit a timely and valid Claim Form, you will not be eligible to share in the Net Settlement Fund. PLEASE NOTE: If you submitted a Claim Form in connection with the Prior Settlement, DO NOT submit another form.

HOW MUCH WILL MY PAYMENT BE?

- 49. At this time, it is not possible to make any determination as to how much any individual HRG Subclass Member may receive from the Settlement.
- 50. Pursuant to the Settlement, Defendants have agreed to pay or cause to be paid a total of \$7,250,000 in cash (the "Settlement Amount"). The Settlement Amount will be deposited into an escrow account. The Settlement Amount plus any interest earned thereon is referred to as the "Settlement Fund." If the Settlement is approved by the Court and the Effective Date occurs, the "Net Settlement Fund" (that is, the Settlement Fund less (i) any Taxes; (ii) any Notice and Administration Costs; (iii) any Litigation Expenses awarded by the Court; (iv) any attorneys' fees awarded by the Court; and (v) any other costs or fees approved by the Court) will be distributed to HRG Subclass Members who submit valid Claim Forms, in accordance with the proposed Plan of Allocation or such other plan of allocation as the Court may approve.
- 51. The Net Settlement Fund will not be distributed unless and until the Court has approved the Settlement and a plan of allocation, and the time for any petition for rehearing, appeal, or

review, whether by certiorari or otherwise, has expired.

- 52. Neither Defendants nor any other person or entity that paid any portion of the Settlement Amount on their behalf are entitled to get back any portion of the Settlement Fund once the Court's order or judgment approving the Settlement becomes Final. Defendants shall not have any liability, obligation, or responsibility for the administration of the Settlement, the disbursement of the Net Settlement Fund, or the plan of allocation.
- 53. Approval of the Settlement is independent from approval of a plan of allocation. Any determination with respect to a plan of allocation will not affect the Settlement, if approved.
- 54. Unless the Court otherwise orders, any HRG Subclass Member who or which did not previously submit a Claim Form and fails to submit a Claim Form postmarked on or before _______, 2021 shall be fully and forever barred from receiving payments pursuant to the Settlement but will in all other respects remain a member of the HRG Subclass and be subject to the provisions of the Stipulation, including the terms of any Judgment entered and the releases given. This means that each HRG Subclass Member releases the Released Plaintiffs' Claims (as defined in ¶ 40 above) against the Defendants' Releasees (as defined in ¶ 41 above) and will be barred and enjoined from prosecuting any of the Released Plaintiffs' Claims against any of the Defendants' Releasees whether or not such HRG Subclass Member submits a Claim Form.
- 55. Participants in, and beneficiaries of, a Spectrum, Old Spectrum, or HRG employee benefit plan covered by ERISA ("ERISA Plan") should NOT include any information relating to their transactions in HRG common stock held through the ERISA Plan in any Claim Form that they submit in this Action. They should include ONLY those shares that they purchased outside the ERISA Plan. Claims based on any ERISA Plan's purchases of HRG common stock during the Class Period may be made by the plans' trustees.
- 56. The Court has reserved jurisdiction to allow, disallow, or adjust on equitable grounds the Claim of any HRG Subclass Member.
- 57. Each Claimant shall be deemed to have submitted to the jurisdiction of the Court with respect to his, her, or its Claim Form.
- 58. Only HRG Subclass Members, *i.e.*, persons and entities who purchased HRG common stock during the Class Period and were damaged as a result of such purchases, will be eligible to share in the distribution of the Net Settlement Fund. Persons and entities that are excluded from the HRG Subclass by definition or that exclude themselves from the HRG Subclass pursuant to request will not be eligible for a payment and should not submit Claim Forms. The only securities that are included in the Settlement are HRG common stock.

PROPOSED PLAN OF ALLOCATION

59. The objective of the Plan of Allocation is to equitably distribute the Net Settlement Fund to those HRG Subclass Members who suffered economic losses as a result of Defendants' alleged violations of the federal securities laws. The calculations made pursuant to the Plan of Allocation are not intended to be estimates of, nor indicative of, the amounts that HRG Subclass Members might have been able to recover after a trial. Nor are the calculations pursuant to the Plan of Allocation intended to be estimates of the amounts that will be paid to Authorized Claimants pursuant to the Settlement. The computations under the Plan of Allocation are only a method to weigh the claims of Claimants against one another for the purposes of making *pro rata*allocations

of the Net Settlement Fund.

- 60. In developing the Plan of Allocation, Lead Plaintiff's damages expert calculated the estimated amount of artificial inflation in the price of HRG common stock allegedly caused by Defendants' alleged false and misleading statements and material omissions. In calculating the estimated artificial inflation allegedly caused by Defendants' alleged misrepresentations and omissions, Lead Plaintiff's damages expert considered price changes in the stock in reaction to the public disclosures allegedly revealing the truth concerning Defendants' alleged misrepresentations and material omissions, adjusting for price changes that were attributable to market or industry forces. The estimated artificial inflation in the price of HRG common stock is stated in Table A-1 at the end of this Notice.
- 61. For losses to be compensable damages under the federal securities laws, the disclosure of the allegedly misrepresented information must be the cause of the decline in the price of the HRG common stock. In this case, Lead Plaintiff alleges that Defendants made false statements and omitted material facts during the period from January 26, 2017 to November 19, 2018, which had the effect of artificially inflating the price of HRG common stock. Lead Plaintiff further alleges that corrective information was released to the market on April 26, 2018 (before the opening of trading) and November 19, 2018 (before the opening of trading), which partially removed the artificial inflation from the price of the HRG common stock (on April 26, 2018) and Spectrum Brands common stock (on November 19, 2018).
- 62. Recognized Loss Amounts for transactions in HRG common stock are calculated under the Plan of Allocation based primarily on the difference in the amount of allegedartificial inflation in the price of HRG common stock at the time of purchase and the time of sale or the difference between the actual purchase price and sale price. In order to have a Recognized Loss Amount under the Plan of Allocation, an HRG Subclass Member who purchased HRG common stock during the Class Period must have held his, her, or its shares through at least one of the dates where new corrective information was released to the market and partially removed the artificial inflation from the price of HRG or Spectrum Brands common stock.
- 63. Based on the formula started below, a "Recognized Loss Amount" will be calculated for each purchase of HRG common stock during the Class Period that is listed on the Claim Form and for which adequate documentation is provided. If a Recognized Loss Amount calculates to a negative number or zero under the formula below, the Recognized Loss Amount for that transaction will be zero.
- 64. For each share of HRG common stock purchased from January 26, 2017 through July 13, 2018 and³
 - (a) sold before April 26, 2018, the Recognized Loss Amount is zero;
 - (b) sold on or after April 26, 2018 but before November 19, 2018, the Recognized Loss Amount is **the lesser of**: (i) the amount of artificial

³ The number of shares and per-share values listed throughout the Plan are based on share quantities and prices post-Merger, as in the Prior Settlement. In the Claim Form, Claimants should report share quantities and prices exactly as reflected in their documentation. That is, transactions in HRG common stock from January 26, 2017 through July 13, 2018 should be listed with the HRG share quantities and prices in effect at the time of those transactions, and the Claims Administrator will make the appropriate adjustments to all reported share prices and quantities so that they are equivalent to the share prices and quantities post-Merger.

- inflation per share on the date of the purchase as stated in Table A *less* the amount of artificial inflation per share on the date of sale listed in Table A; or (ii) the purchase price per share *less* the sale price per share;
- (c) sold from November 19, 2018 through February 15, 2019, the Recognized Loss Amount is **the least of**: (i) the amount of artificial inflation per share on the date of purchase as stated in Table A; (ii) the purchase price per share *less* the sale price per share; or (iii) the purchase price per share *less* the average closing price between November 19, 2018 and the date of sale as stated in Table B below; or
- (d) held at the close of trading on February 15, 2019, the Recognized Loss Amount is equal to **the lesser of**: (i) the amount of artificial inflation per share on the date of purchase as stated in Table A; or (ii) the purchase price per share *less* \$49.35.⁴

ADDITIONAL PROVISIONS

- 65. **Calculation of Claimant's "Recognized Claim":** A Claimant's "Recognized Claim" will be the amount of his, her, or its Recognized Loss Amounts, as calculated above.
- 66. **FIFO Matching:** If an HRG Subclass Member made more than one purchase or sale of HRG common stock during the Class Period, all purchases and sales will be matched a First In, First Out ("FIFO") basis. Class Period sales will be matched first against any holdingsof HRG common stock at the beginning of the Class Period, and then against purchases in chronological order, beginning with the earliest purchase made during the Class Period.
- 67. **"Purchase/Sale" Dates:** Purchases and sales of HRG common stock will be deemed to have occurred on the "contract" or "trade" date as opposed to the "settlement" or "payment" date. However, the receipt or grant by gift, inheritance, or operation of law of HRG common stock during the Class Period shall not be deemed a purchase or sale for the calculation of a Claimant's Recognized Loss Amount, nor shall the receipt or grant be deemed an assignment of any claim relating to the purchase/sale of the stock unless (i) the donor or decedent purchased the HRG common stock during the Class Period; (ii) the instrument of gift or assignment specifically provides that it is intended to transfer such rights; and (iii) no Claim was submitted by or on behalf of the decedent, or by anyone else with respect to those shares.
- 68. **Short Sales:** The date of covering a "short sale" is deemed to be the date of purchase of the HRG common stock. The date of a "short sale" is deemed to be the date of sale of the HRG common stock. In accordance with the Plan of Allocation, however, the Recognized Loss Amount on "short sales" and the purchases covering "short sales" is zero.
- 69. In the event that a Claimant has an opening short position in HRG common stock, the earliest purchases of HRG common stock during the Class Period will be matched against such

⁴ Pursuant to Section 21(D)(e)(1) of the Exchange Act, "in any private action arising under this title in which the plaintiff seeks to establish damages by reference to the market price of a security, the award of damages to the plaintiff shall not exceed the difference between the purchase or sale price paid or received, as appropriate, by the plaintiff for the subject security and the mean trading price of that security during the 90-day period beginning on the date on which the information correcting the misstatement or omission that is the basis for the action is disseminated to the market." The average (mean) closing price of Spectrum common stock during the 90-day look-back period from November 19, 2018 through February 15, 2019 was \$49.35.

opening short position, and not be entitled to a recovery, until that short position is fully covered.

- 70. **Shares Purchased/Sold Through the Exercise of Options:** Option contracts are not securities eligible to participate in the Settlement. With respect to shares of HRG common stock purchased or sold through the exercise of an option, the purchase/sale date of the HRG common stock is the exercise date of the option and the purchase/sale price is the exercise price of the option.
- 71. **Market Gains and Losses:** The Claims Administrator will determine if the Claimant had a "Market Gain" or a "Market Loss" with respect to his, her, or its overall transactions in HRG common stock during the Class Period. For purposes of making this calculation, the Claims Administrator shall determine the difference between (i) the Claimant's Total Purchase Amount⁵ and (ii) the sum of the Claimant's Total Sales Proceeds⁶ and the Claimant's Holding Value.⁷ If the Claimant's Total Purchase Amount *minus* the sum of the Claimant's Total Sales Proceeds and the Holding Value is a positive number, that number will be the Claimant's MarketLoss; if the number is a negative number or zero, that number will be the Claimant's Market Gain.
- 72. If a Claimant had a Market Gain with respect to his, her, or its overall transactions in HRG common stock, the value of the Claimant's Recognized Claim will be zero, and the Claimant will not be eligible to receive a payment in the Settlement but will, nonetheless, be bound by the Settlement. If a Claimant suffered an overall Market Loss with respect to his, her, or its overall transactions in HRG common stock but that Market Loss was less than the Claimant's Recognized Claim, then the Claimant's Recognized Claim will be limited to the amount of the Market Loss.
- Authorized Claimants who are entitled to receive payment out of the Net Settlement Fund is greater than the Net Settlement Fund, each Authorized Claimant will receive his, her, or its *pro rata* share of the Net Settlement Fund. The *pro rata* share will be the Authorized Claimant's Recognized Claim divided by the total of Recognized Claims of all Authorized Claimants, multiplied by the total amount in the Net Settlement Fund. If the Net Settlement Fund exceeds the sum total amount of the Recognized Claims of all Authorized Claimants entitled to receive payment out of the Net Settlement Fund, the excess amount in the Net Settlement Fund will be distributed *pro rata* to all Authorized Claimants entitled to receive payment.
- 74. If an Authorized Claimant's Distribution Amount calculates to less than \$10.00, it will not be included in the calculation of Authorized Claimants' *pro rata* shares, and no distribution will be made to that Authorized Claimant.
- 75. After the initial distribution of the Net Settlement Fund, the Claims Administrator will make reasonable and diligent efforts to have Authorized Claimants cash their distribution checks. To the extent any monies remain in the Net Settlement Fund after the initial distribution, if Lead

⁵ The "Total Purchase Amount" is the total amount the Claimant paid (excluding any fees, commissions, and taxes) for all HRG common stock purchased during the Class Period.

⁶ The proceeds of any sales of HRG common stock during the Class Period that are matched on a FIFO basis (see ¶ 66) with Claimant's opening position in HRG common stock as of the opening of trading on January 26, 2017 will not be considered for purposes of calculating market gains or losses. The total amount received (not deducting any fees, commissions, and taxes) for sales of the remaining HRG common stock sold during the Class Period is the "Total Sales Proceeds."

⁷ The Claims Administrator shall ascribe a "Holding Value" of \$48.05 per share to each share of Spectrum Brands common stock that was the result of a conversion from HRG shares purchased during the Class Period.

Counsel, in consultation with the Claims Administrator, determines that it is cost-effective to do so, the Claims Administrator, no less than seven (7) months after the initial distribution, will conduct another distribution of the funds remaining after payment of any unpaid fees and expenses incurred in administering the Settlement, including for that distribution, to Authorized Claimants who have cashed their initial distributions and who would receive at least \$10.00 from the subsequent distribution. Additional distributions to Authorized Claimants who have cashed their prior checks and who would receive at least \$10.00 on such additional distributions may occur thereafter if Lead Counsel, in consultation with the Claims Administrator, determines that additional distributions, after the deduction of any additional fees and expenses incurred in administering the Settlement, including for such distributions, would be cost-effective. At such time as it is determined that the distribution of funds remaining in the Net Settlement Fund is not cost-effective, the remaining balance will be contributed to non-sectarian, not-for-profit 501(c)(3) organization(s), to be recommended by Lead Counsel and approved by the Court.

- 76. Payment pursuant to the Plan of Allocation, or such other plan of allocation as may be approved by the Court, will be conclusive against all Claimants. No person or entity shall have any claim against Lead Plaintiff, Lead Counsel, Lead Plaintiff's damages expert, the Claims Administrator, or any other agent designated by Lead Counsel, or Defendants' Releasees and/or their respective counsel, arising from distributions made substantially in accordance with the Stipulation, the plan of allocation approved by the Court, or any order of the Court. Lead Plaintiff and Defendants, and their respective counsel, and all other Releasees shall have no liability whatsoever for the investment or distribution of the Settlement Fund or the Net Settlement Fund, the plan of allocation, or the determination, administration, calculation, or payment of any claim or nonperformance of the Claims Administrator, the payment or withholding of taxes (including interest and penalties) owed by the Settlement Fund, or any losses incurred in connectiontherewith.
- 77. The Plan of Allocation set forth herein is the plan that is being proposed to the Court for its approval by Lead Plaintiff after consultation with its damages expert. The Court may approve this plan as proposed, or it may modify the Plan of Allocation without further notice to the Class. Any Orders regarding any modification of the Plan of Allocation will be posted on the case website, www.HRGSecuritiesLitigation.com.

WHAT PAYMENT ARE THE ATTORNEYS FOR THE HRG SUBCLASS SEEKING? HOW WILL THE LAWYERS BE PAID?

78. Lead Counsel have not received any payment for their services in pursuing claims asserted in the Action on behalf of the HRG Subclass, nor has Lead Counsel been paid for their litigation expenses. Before final approval of the Settlement, Lead Counsel will apply to the Court for an award of attorneys' fees for Lead Counsel in an amount not to exceed 22% of the Settlement Fund. At the same time, Lead Counsel also intends to apply for payment of Litigation Expenses incurred by Lead Counsel in an amount not to exceed \$500,000, which may include an application for reimbursement of the reasonable costs and expenses incurred by Lead Counsel directly related to their representation of the HRG Subclass, pursuant to the PSLRA. The Court will determine the amount of any award of attorneys' fees or Litigation Expenses. Such sums as may be approved by the Court will be paid from the Settlement Fund. HRG Subclass Members are not personally liable for any such fees or expenses.

WHAT IF I DO NOT WANT TO BE A MEMBER OF THE SETTLEMENT CLASS? HOW DO I EXCLUDE MYSELF?

- 79. Each HRG Subclass Member will be bound by all determinations and judgments in this lawsuit, whether favorable or unfavorable, unless such person or entity mails or delivers a written Request for Exclusion from the HRG Subclass, addressed to HRG Securities Litigation, EXCLUSIONS, c/o JND Legal Administration, P.O. Box 91427, Seattle, WA 98111. Request for Exclusion must be *received* no later than ____, 2021. You will not be able to exclude yourself from the HRG Subclass after that date. Each Request for Exclusion must (i) state the name, address, and telephone number of the person or entity requesting exclusion, and in the case of entities, the name and telephone number of the appropriate contact person; (ii) state that such person or entity "requests exclusion from the HRG Subclass in Jet Capital Master Fund, L.P. v. HRG Group, Inc., Case No. 21-cv-552-jdp"; (iii) state: (A) the number of shares of HRG common stock that the person or entity requesting exclusion owned as of the opening of trading on January 26, 2017; and (B) the number of shares of HRG common stock that the person or entity requesting exclusion purchased and sold during the periodfrom January 26, 2017 to July 13, 2018, including the dates, number of shares, and prices of each such purchase and sale; and (iv) be signed by the person or entity requesting exclusion or an authorized representative. A Request for Exclusion that does not provide all the information called for in this paragraph and is not received within the time stated above will be invalid and will not be allowed. Lead Counsel may request that the person or entity requesting exclusion submit additional transaction information or documentation sufficient to prove his, her, or its holdings and trading in HRG common stock.
- 80. If you do not want to be part of the HRG Subclass, you must follow these instructions for exclusion even if you have pending, or later file, another lawsuit, arbitration, or otherproceeding relating to any Released Plaintiffs' Claim against any of the Defendants' Releasees.
- 81. If you exclude yourself from the HRG Subclass, you should understand that Defendants and the other Defendants' Releasees will have the right to assert all defenses they may have to any claims that you may seek to assert, including, without limitation, the defense that any such claims are untimely under applicable statutes of limitations and statutes of repose.
- 82. If you ask to be excluded from the HRG Subclass, you will not be eligible to receive any payment out of the Net Settlement Fund.
- 83. Spectrum has the right to terminate the Settlement if valid requests for exclusion are received from persons and entities entitled to be members of the HRG Subclass in an amountthat exceeds an amount agreed to by Lead Plaintiff and Spectrum.

WHEN AND WHERE WILL THE COURT DECIDE WHETHER TO APPROVE THE SETTLEMENT? DO I HAVE TO COME TO THE HEARING? MAY I SPEAK AT THE HEARING IF I DON'T LIKE THE SETTLEMENT?

84. HRG Subclass Members do not need to attend the Settlement Fairness Hearing. The Court will consider any submission made in accordance with the provisions below even if an HRG Subclass Member does not attend the hearing. You can participate in the Settlement without attending the Settlement Fairness Hearing.

- 85. Please Note: The date and time of the Settlement Fairness Hearing may change without further written notice to the HRG Subclass. In addition, the ongoing COVID-19 health emergency is a fluid situation that creates the possibility that the Court may decide to conduct the Settlement Fairness Hearing by telephonic or video conference, or otherwise allow HRG Subclass Members to appear at the hearing by phone or video, without further written notice to the HRG Subclass. In order to determine whether the date and time of the Settlement Fairness Hearing have changed, or whether HRG Subclass Members must or may participate by phone or video, it is important that you monitor the Court's docket and the Settlement website, www.HRGSecuritiesLitigation.com, before making any plans to attend the Settlement Fairness Hearing. Any updates regarding the Settlement Fairness Hearing, including any changes to the date or time of the hearing or updates regarding in-person or telephonic the hearing, will be posted at to the Settlement www.HRGSecuritiesLitigation.com. Also, if the Court requires or allows HRG Subclass Members to participate in the Settlement Fairness Hearing by telephone or video conference, the information needed to access the conference will be posted to the Settlement website, www.HRGSecuritiesLitigation.com.
- 86. The Settlement Fairness Hearing will be held on , 2022 at : .m., before the Honorable James D. Peterson, either in person at the United States District Court for the Western District of Wisconsin, Courtroom 260, United States Courthouse, 120 North Henry Street, Madison, WI 53703400, or by telephone or video conference (in the discretion of the Court), to determine, among other things: (i) whether the proposed Settlement on the terms and conditions provided for in the Stipulation is fair, reasonable, and adequate to the HRG Subclass, and should be finally approved by the Court; (ii) whether, for purposes of the Settlementonly, the Action should be certified as a class action on behalf of the HRG Subclass, Lead Plaintiff should be certified as Class Representative for the HRG Subclass, and Lead Counsel should be appointed as Class Counsel for the HRG Subclass; (iii) whether the claims asserted in the Action on behalf of the HRG Subclass should be dismissed with prejudice against Defendants and the Releases specified and described in the Stipulation (and in this Notice) should be granted; (iv) whether the proposed Plan of Allocation should be approved as fair and reasonable; (v) whether Lead Counsel's application for an award of attorneys' fees and Litigation Expenses should be approved; and (vi) any other matters that may properly be brought before the Court in connection with the Settlement. The Court reserves the right to certify the HRG Subclass; approve the Settlement, the Plan of Allocation, and Lead Counsel's motion for an award of attorneys' fees and Litigation Expenses; and consider any other matter related to the Settlement at or after the Settlement Fairness Hearing without further notice to the members of the HRG Subclass.
- 87. Any HRG Subclass Member who or which does not request exclusion may object to the Settlement, the proposed Plan of Allocation, or Lead Counsel's motion for attorneys' fees and Litigation Expenses. Objections must be in writing. To object, you must: (1) file any written objection, together with copies of all other papers and briefs supporting the objection, with the Clerk's Office at the U.S District Court for the Western District of Wisconsin at the address set forth below on or before _______, 2021; (2) serve the papers on Lead Counsel and onDefendants' Counsel at the addresses set forth below so that the papers are *received* on or before _______, 2021; and (3) email a copy of your objection to HRG@rksllp.com and rrosen@paulweiss.com_by ________, 2021.

- 88. Any objection must: (i) identify the case name and docket number, Jet Capital Master Fund, L.P. v. HRG Group, Inc., Case No. 21-cv-552-jdp; (ii) state the name, address, and telephone number of the person or entity objecting and must be signed by the objector; (iii) state with specificity the grounds for the HRG Subclass Member's objection, including any legal and evidentiary support the HRG Subclass Member wishes to bring to the Court's attention and whether the objection applies only to the objector, to a specific subset of the HRG Subclass, or to the entireHRG Subclass; and (iv) include documents sufficient to prove membership in the HRG Subclass, including documents showing (A) the number of shares of HRG common stock that the objecting HRG Subclass Member owned as of the opening of trading on January 26, 2017; and (B) the number of shares of HRG common stock that the objecting HRG Subclass Member purchased and sold during the period from January 26, 2017 to July 13, 2018, including the dates, number of shares, and prices of each such purchase and sale. Documentation establishing membership in the HRG Subclass must consist of copies of brokerage confirmation slips or monthly brokerage account statements, or an authorized statement from the objector's broker containing the transactional and holding information found in a broker confirmation slip or account statement. Persons who intend to object and desire to present evidence at the Settlement Fairness Hearing must include in their written objection or notice of appearance the identity of any witnesses they may call to testify and exhibits they intend to introduce into evidence at the hearing. Such persons may be heard orally at the discretion of the Court.
- 91. You are not required to hire an attorney to represent you in making written objections or in appearing at the Settlement Fairness Hearing (unless you are a corporation or other entity that may appear in Court only through counsel). However, if you decide to hire an attorney, it will be at your own expense, and that attorney must file a notice of appearance with the Court and serve it on Lead Counsel and Defendants' Counsel at the addresses set forth in ¶ 87 above so that the notice is *received* on or before , 2021.
- 92. The Settlement Fairness Hearing may be adjourned by the Court without further written notice to the HRG Subclass. If you intend to attend the Settlement Fairness Hearing, you should confirm the date and time on the Court's docket or with Lead Counsel.
- 93. Unless the Court orders otherwise, any HRG Subclass Member who does not object in the manner described above will be deemed to have waived any objection and shall be forever foreclosed from making any objection to the proposed Settlement, the proposed Plan of Allocation, or Lead Counsel's motion for an award of attorneys' fees and Litigation Expenses. HRG Subclass Members do not need to appear at the Settlement Fairness Hearing or take any other action to indicate their approval.

WHAT IF I BOUGHT SHARES ON SOMEONE ELSE'S BEHALF?

94. If you purchased shares of HRG common stock from January 26, 2017 to July 13, 2018 for the beneficial interest of persons or organizations other than yourself, you must either: (1) within seven (7) calendar days of receipt of this Notice, request from the Claims Administrator sufficient copies of the Notice and Claim Form (the "Notice Packet") to forward to all such beneficial owners and within seven (7) calendar days of receipt of those Notice Packets forward them to all such beneficial owners; or (2) within seven (7) calendar days of receipt of this Notice, provide a list of the names, addresses, and, if available, email addresses of all such beneficial owners to HRG Securities Litigation, c/o JND Legal Administration, P.O. Box 91427, Seattle, WA 98111.

However, if you previously provided names and addresses of potential settlement class members in this Action to the Claims Administrator in connection with the Prior Settlement, you are not required to provide those names and addresses again. You are only required to provide the Claims Administrator with names and addresses of beneficial owners described above that were not previously provided, or if there are any name or address changes. In addition, if you choose the first option, you must send a statement to the Claims Administrator confirming that the mailing was made as directed and retain the list of names and addresses for use in connection with any possible future notice to the HRG Subclass. [PROPOSED] JUDGMENT APPROVING CLASS ACTION SETTLEMENT

WHEREAS, a consolidated securities class action is pending in this Court entitled *In re Spectrum Brands Securities Litigation*, No. 19-cv-347-jdp (the "*Spectrum* Action");

WHEREAS, on August 27, 2021, the Court entered an Order severing the claims of purchasers of HRG Group, Inc. ("HRG") common stock during the Class Period in the *Spectrum* Action from the claims of purchasers of Spectrum and Old Spectrum common stock during the Class Period, and that continue in the *Spectrum* Action;

WHEREAS, on August 31, 2021, pursuant to the August 27, 2021 Order, the Court created the action entitled *Jet Capital Master Fund, L.P. v. HRG Group, Inc.*, No. 21-cv-552-jdp, for claims of purchasers of HRG common stock during the Class Period to continue and this action is referred to herein as the "Action";

WHEREAS, (a) Jet Capital Master Fund, L.P. ("Jet Capital" or "Lead Plaintiff"), on behalf of itself and the HRG Subclass (defined below); and (b) defendants Spectrum Brands Holdings, Inc. ("Spectrum" or the "Company"), Spectrum Brands Legacy, Inc. ("Old Spectrum"), HRG, and Andreas R. Rouvé, David M. Maura, and Douglas L. Martin (collectively, the "Individual Defendants" and, together with Spectrum, Old Spectrum, and HRG, "Defendants") (Lead Plaintiff

and Defendants, together, the "Parties") have entered into a Stipulation and Agreement of Settlement, dated October 8, 2021 (the "Stipulation"), that provides for a dismissal with prejudice of the claims asserted by the HRG Subclass against Defendants in the Action on the terms and conditions set forth in the Stipulation, subject to the approval of this Court (the "Settlement");

WHEREAS, unless otherwise defined in this Judgment, the capitalized terms herein shall have the same meaning as they have in the Stipulation;

WHEREAS, due and adequate notice has been given to the HRG Subclass;

WHEREAS, the Court having reviewed and considered the Stipulation, all papers filed and proceedings held herein in connection with the Settlement, all oral and written comments received

regarding the Settlement, and the record in the Action, and good cause appearing therefor;

IT IS HEREBY ORDERED, ADJUDGED, AND DECREED:

- 1. <u>Jurisdiction</u> The Court has jurisdiction over the subject matter of the Action, and all matters relating to the Settlement, as well as personal jurisdiction over all of the Parties and each of the HRG Subclass Members.
- 2. <u>Incorporation of Settlement Documents</u> This Judgment incorporates and makes a part hereof: (a) the Stipulation filed with the Court on October 8, 2021; and (b) the Notice and the Summary Notice, both of which were filed with the Court on _______, 2021.
- Class Certification for Settlement Purposes The Court hereby certifies for the purposes of the Settlement only, the Action as a class action pursuant to Rules 23(a) and (b)(3) of the Federal Rules of Civil Procedure on behalf of the HRG Subclass consisting of all persons and entities that purchased common stock of HRG from January 26, 2017 to July 13, 2018 (the "Class Period"), and were damaged thereby. Excluded from the Spectrum Subclass are: (i) Defendants (including Spectrum); (ii) the Immediate Family members of the Individual Defendants; (iii) the Officers and directors of Old Spectrum, Spectrum, and HRG currently and during the period from January 26, 2017 to November 19, 2018 and their Immediate Family members; (iv) any entity in which any of the foregoing excluded persons or entities has or had a controlling interest; and (v) the legal representatives, heirs, successors, or assigns of any such excluded person or entity. Also excluded from the HRG Subclass are the persons listed on Exhibit 1 hereto who are excluded from the HRG Subclass pursuant to their request.
- 4. <u>Settlement Class Findings</u> For purposes of the Settlement only, the Court finds that each element required for certification of the HRG Subclass pursuant to Rule 23 of the Federal Rules of Civil Procedure has been meet: (a) the members of the Spectrum Subclass are so

numerous that their joinder in the Action would be impracticable; (b) there are questions of law and fact common to the HRG Subclass which predominate over any individual questions;(c) the claims of Lead Plaintiff in the Action are typical of the claims of the HRG Subclass; (d) Lead Plaintiff and Lead Counsel have and will fairly and adequately represent and protect theinterests of the HRG Subclass; and (e) a class action is superior to other available methods for the fair and efficient adjudication of the Action.

- Adequacy of Representation Pursuant to Rule 23 of the Federal Rules of Civil Procedure, and for the purposes of the Settlement only, the Court hereby certifies Lead Plaintiff Jet Capital Master Fund, L.P. as Class Representative for the HRG Subclass and appoints Lead Counsel Rolnick Kramer Sadighi LLP as Class Counsel for the HRG Subclass. The Court finds that Lead Plaintiff and Lead Counsel have fairly and adequately represented the HRG Subclass both in terms of litigating the Action and for purposes of entering into and implementing the Settlement and have satisfied the requirements of Federal Rules of Civil Procedure 23(a)(4) and 23(g), respectively.
- 6. Notice The Court finds that the dissemination of the Notice and the publication of the Summary Notice: (a) were implemented in accordance with the Preliminary Approval Order; (b) constituted the best notice practicable under the circumstances; (c) constituted notice that was reasonably calculated, under the circumstances, to apprise HRG Subclass Members of (i) the pendency of the Action, (ii) the effect of the proposed Settlement (including the Releases to be provided thereunder), (iii) Lead Counsel's motion for an award of attorneys' fees and Litigation Expenses, (iv) their right to object to any aspect of the Settlement, the Plan of Allocation, and/or Lead Counsel's motion for attorneys' fees and Litigation expenses, (v) their right to exclude themselves from the HRG Subclass, and (vi) their right to appear at the Settlement Fairness

Hearing; (d) constituted due, adequate, and sufficient notice to all persons and entities entitled to receive notice of the proposed Settlement; and (e) satisfied the requirements of Rule 23 of the Federal Rules of Civil Procedure, the United States Constitution (including the Due Process Clause), the Private Securities Litigation Reform Act of 1995, 15 U.S.C. § 78u-4, as amended, and all other applicable law and rules. [There have been no objections by HRG Subclass Members to the Settlement.]

- 7. Final Settlement Approval and Dismissal of Claims Pursuant to, and in accordance with, Rule 23(e)(2) of the Federal Rules of Civil Procedure, this Court hereby fully and finally approves the Settlement set forth in the Stipulation in all respects (including, without limitation: the amount of the Settlement; the Releases provided for therein; and the dismissal with prejudice of the claims asserted against Defendants in the Action on behalf of the HRG Subclass), and finds that the Settlement is, in all respects, fair, reasonable, and adequate to the HRG Subclass. Specifically, the Court finds that: (a) Lead Plaintiff and Lead Counsel have adequately represented the HRG Subclass; (b) the Settlement was negotiated by the Parties at arm's length; (c) the relief provided for the HRG Subclass under the Settlement is adequate taking into account the costs, risks, and delay of further litigation, including trial and appeal; the proposed means of distributing the Settlement Fund to the HRG Subclass; and the proposed attorneys' fee award; and (d) the Settlement treats members of the HRG Subclass equitably relative to each other. The Parties are directed to implement, perform, and consummate the Settlement in accordance with the terms and provisions contained in the Stipulation.
- 8. All of the claims asserted against Defendants in the Action by the HRG Subclass are hereby dismissed with prejudice. The Parties shall bear their own costs and expenses, except as otherwise expressly provided in the Stipulation.

- 9. **Binding Effect** The terms of the Stipulation and of this Judgment shall be forever binding on Defendants, Lead Plaintiff, and all other HRG Subclass Members (regardless of whether or not any individual HRG Subclass Member submits a Claim Form or seeks or obtains a distribution from the Net Settlement Fund), as well as their respective successors and assigns. The persons listed on Exhibit 1 hereto are excluded from the HRG Subclass pursuant to their request and are not bound by the terms of the Stipulation or this Judgment.
- 10. **Releases** The Releases set forth in paragraphs 5 and 6 of the Stipulation, together with the definitions contained in paragraph 1 of the Stipulation relating thereto, are expressly incorporated herein in all respects. The Releases are effective as of the Effective Date. Accordingly, this Court orders that:
 - (a) Without further action by anyone, and subject to paragraph 11 below, upon the Effective Date of the Settlement, Lead Plaintiff and each of the other HRG Subclass Members shall be deemed to have, and by operation of law and of this Judgment shall have, fully, finally, and forever compromised, settled, released, resolved, relinquished, waived, and discharged each and every Released Plaintiffs' Claim against Defendants and the other Defendants' Releasees, and shall forever be barred and enjoined from prosecuting any or all of the Released Plaintiffs' Claims against any of the Defendants' Releasees. This Release shall not apply to any of the Excluded Plaintiffs' Claims (as that term is defined in paragraph 1(r) of the Stipulation).
 - (b) Without further action by anyone, and subject to paragraph 11 below, upon the Effective Date of the Settlement, Defendants, on behalf of themselves and their respective successors, assigns, executors, administrators, representatives,

attorneys, and agents, in their capacities as such, shall be deemed to have, and by operation of law and of this Judgment shall have, fully, finally, and forever compromised, settled, released, resolved, relinquished, waived, and discharged each and every Released Defendants' Claim against Lead Plaintiff and the other Plaintiffs' Releasees, and shall forever be barred and enjoined from prosecuting any or all of the Released Defendants' Claims against any of the Plaintiffs' Releasees. This Release shall not apply to any of the Excluded Defendants' Claims (as that term is defined in paragraph 1(q) of the Stipulation).

- 11. Notwithstanding paragraphs 10(a) (b) above, nothing in this Judgment shall bar any action by any of the Parties to enforce or effectuate the terms of the Stipulation or this Judgment.
- 12. **Rule 11 Findings** The Court finds and concludes that the Parties and their respective counsel have complied in all respects with the requirements of Rule 11 of the Federal Rules of Civil Procedure in connection with the institution, prosecution, defense, and settlement of the Action.
- 13. **No Admissions** Neither this Judgment, the Term Sheet, the Stipulation (whether or not consummated), including the exhibits thereto and the Plan of Allocation contained therein (or any other plan of allocation that may be approved by the Court), the negotiations leading to the execution of the Term Sheet and the Stipulation, nor any proceedings taken pursuant to or in connection with the Term Sheet, the Stipulation, and/or approval of the Settlement (including any arguments proffered in connection therewith):
 - (a) shall be offered against any of the Defendants' Releasees as evidence of, or construed as, or deemed to be evidence of any presumption, concession, or

admission by any of the Defendants' Releasees with respect to the truth of any fact alleged by Lead Plaintiffs or the validity of any claim that was or could have been asserted or the deficiency of any defense that has been or could have been asserted in this Action or in any other litigation, or of any liability, negligence, fault, or other wrongdoing of any kind of any of the Defendants' Releasees or in any way referred to for any other reason as against any of the Defendants' Releasees, in any arbitration proceeding or other civil, criminal, or administrative action or proceeding, other than such proceedings as may be necessary to effectuate the provisions of the Stipulation;

- (b) shall be offered against any of the Plaintiffs' Releasees, as evidence of, or construed as, or deemed to be evidence of any presumption, concession, or admission by any of the Plaintiffs' Releasees that any of their claims are without merit, that any of the Defendants' Releasees had meritorious defenses, or that damages recoverable under the Complaint would not have exceeded the Settlement Amount or with respect to any liability, negligence, fault, or wrongdoing of any kind, or in any way referred to for any other reason as against any of the Plaintiffs' Releasees, in any arbitration proceeding or other civil, criminal, or administrative actionor proceeding, other than such proceedings as may be necessary to effectuate the provisions of the Stipulation; or
- shall be construed against any of the Releasees as an admission, concession, or presumption that the consideration to be given under the Settlement represents the amount which could be or would have been recovered after trial; *provided*, *however*, that the Parties and the Releasees and their respective counsel may refer to

this Judgment and the Stipulation to effectuate the protections from liability granted hereunder and thereunder or otherwise to enforce the terms of the Settlement.

- 14. **Retention of Jurisdiction** Without affecting the finality of this Judgment in any way, this Court retains continuing and exclusive jurisdiction over: (a) the Parties for purposes of disposition of the Settlement Fund; (c) an motion for an award of attorneys' fees and/or Litigation Expenses by Lead Counsel in the Action that will be paid from the Settlement Fund; (d) any motion to approve the Plan of Allocation; (e) any motion to approve the Class Distribution Order; and (f) the HRG Subclass for all matters relating to the Action.
- 15. Separate orders shall be entered regarding approval of a plan of allocation and the motion of Lead Counsel for an award of attorneys' fees and Litigation Expenses. Such orders shall in no way affect or delay the finality of this Judgment and shall not affect or delay the Effective Date of the Settlement.
- 16. Modification of the Agreement of Settlement Without further approval from the Court, Lead Plaintiff and Defendants are hereby authorized to agree to and adopt such amendments or modifications of the Stipulation or any exhibits attached thereto to effectuate the Settlement that: (a) are not materially inconsistent with this Judgment; and (b) do not materially limit the rights of HRG Subclass Members in connection with the Settlement. Without further order of the Court, Lead Plaintiff and Defendants may agree to reasonable extensions of time to carry out any provisions of the Settlement.
- 17. <u>Termination of Settlement</u> If the Settlement is terminated as provided in the Stipulation or the Effective Date of the Settlement otherwise fails to occur, this Judgment shall be vacated and rendered null and void, and shall be of no further force and effect, except as otherwise provided by the Stipulation, and this Judgment shall be without prejudice to the rights of Lead

Plaintiffs, the other HRG Subclass Members, and Defendants, and Lead Plaintiffs and Defendants shall revert to their respective positions in the Action as of immediately prior to the execution of the Term Sheet on September 20, 2021, as provided in the Stipulation.

18. **Entry of Final Judgment** – There is no just reason to delay the entry of this Judgment as a final judgment in this Action. Accordingly, the Clerk of the Court is expressly directed to immediately enter this final judgment in this Action.
